Local Innovations fund criteria/guidance on good practice – Pat Whyte

The local innovation funds criteria were circulated and the Pat explained that new Local Innovations Fund has two sets of criteria which must be met.

- 1. Based on the City's Core Priorities : Children ,Job &Skills, Housing and Health
- 2. The Local Innovations Fund Priorities: Citizens' Independence & Well-being, New approach to Investment, Active Citizenship, Clean streets and Improvement to local area.

Pat went onto explain that this fund was **not Community Chest** it therefore could not be used for the following:

- 1. One off equipment purchases e.g. Hanging basket ,CCTV
- 2. One off events
- 3. On-going cost



- 4. Contracted staff
- 5. Commissioning Reports
- 6. Monies to replace lost revenue budgets or core funding

What are the priorities for the Ward? – The group identified the following as Ward priorities

- Jobs and skills Re-skilling the over 50's
- Healthy Villages Mental Health issues and Dementia .Local café and get together areas
- Crime Reduction
- Public spaces enhancement
