The Chairman introduced the Members and officers present and the Chair asked if there were any preliminary points for the Sub-Committee to consider.

The Chairman then explained the hearing procedure prior to inviting the Licensing Officer, Bhapinder Nandhra to outline the report.

Afterwards, the Chairman invited the applicant or their representative to outline their application, at which stage Leo Charalambides made the following points: -

- a) That it was an interesting application.
- b) The applicant is the sole director who already had other local business in the area including an accident repair company.
- c) The applicant was keen to give back to the community and that was the reason behind the application.

#### Licensing Sub-Committee B – 9 March 2021

- d) The venue had been used for licensing activity in the past.
- e) The hours applied for were modest.
- f) The capacity of the venue was about 200 people.
- g) West Midlands Police and Environmental Health had agreed conditions with the applicant.
- h) They hoped that the premises (in the daytime) would be used as a work space and community facility offering tea and coffee. Further, 25% of the profits would go back into the community.
- i) The DPS was very experienced and had ran large venues before.
- j) The applicant's daughter would also be working within the company. She is a University graduate and would be involved in the Human Resources/Health and Safety side of the business.
- k) Carl Moore covered all the basics and the additional conditions.
- I) The representations were considered, and they were content that the public aspects were covered by the operating schedule.
- m) There was also detailed correspondence between the applicant and the objectors which was included in the paperwork. The residents had the applicants contact details and they had dealt with it in an open way.

In answer to questions from Members, Leo Charalambides, on behalf of the applicant made the following points: -

- a) That they had reduced the hours, considered the role of SIA staff and would have additional provision if necessary.
- b) They would risk assess all events.

The Chairman invited the applicant and their representative to make a closing submission, however, they did not wish to add anything.

At this stage the meeting was adjourned in order for the Sub Committee to make a decision and all parties left the Teams meeting. The Members, Committee Lawyer and Committee Manager conducted the deliberations in private and decision of the Sub-Committee was sent out to all parties as follows: -

#### 5/090321 **RESOLVED**:-

That the application by The Rhodehouse Limited for a premises licence in respect of The Rhodehouse, 1<sup>st</sup> Floor, 123 The Parade, Sutton Coldfield B72 1PU <u>be granted</u> with the following hours:

- Amended Hours for Alcohol: Sunday to Friday 09:00-23:30; Saturday 09:00-00:00
- Amended Hours for Regulated Entertainment: Sunday to Friday – 11:00-23:00; Saturday 11:00-23:30
- Amended Operating Hours: Sunday to Friday 08:00-00:00; Saturday 08:00-00:30hrs

The licence shall also be subject to all the conditions agreed in advance of the meeting with the responsible authorities, namely West Midlands Police and Environmental Health, as follows:

- External doors and windows shall be kept closed, other than for access and egress, whenever regulated entertainment is provided (i.e. music levels that require customers to raise voices)
- Customers will not be permitted to carry open bottles or glasses beyond the licensed area. Exception is the outdoor smoking terrace on the 1st Floor
- 3) No licensable activities are to be carried out on the 1st floor smoking terrace
- 4) The premises will risk assess its standard operating procedures covering seven days a week, included in this risk assessment will be any security provisions. A copy of risk assessment to be made available to West Midlands Police Licensing Department
- 5) The premises shall risk assess the need for SIA registered door supervisors. This shall be documented and kept on the premises
- 6) The premises shall maintain an incident register, with details of incidents that occur inside and immediately outside the premises. The incident book will be available for inspection at any time by any responsible authority
- 7) There will always be a staff member on site, fully trained in the operation of the CCTV who will be able to download selected footage onto a storage device to be readily available for the licensing authorities
- 8) In the event of the hard disk drive being replaced for any reason, the old hard drive must be kept at the premises for 31 days and readily available to the licensing authorities
- 9) The outside terrace shall only be used for customers to smoke between 10am and 11.30pm Monday to Saturday and 10 to 10.30pm Sunday
- 10) The Designated Premises Supervisor shall be responsible for ensuring that the smoking terrace does not create a nuisance to neighbours at their property, and if necessary restrict the number of people utilising the smoking areas at any one time
- 11) Notices shall be displayed near the entrances, exits and rear smoking area of the premises advising customers who wish to use the outside smoking facilities that they should do so with respect for the nearby residents and keep noise levels to a

#### minimum

12) There shall be a lobbied area created at the ground floor entrance to the premises or alternatively the first floor entrance. This will ensure that whilst regulated entertainment is taking place one door will remain closed whilst persons are entering and exiting the site

In addition the licence will also include a further condition, agreed (in advance of the meeting) between the applicant and a neighbouring resident, namely:

 All the windows of the premises (9 in total) overlooking the neighbouring residence will have vinyl screens placed on the inside so that there is no visibility of the neighbouring residence. When viewed from the outside, and from the neighbouring residence, the vinyl screens will be blank without any images

Those matters detailed in the operating schedule and the relevant mandatory conditions under the Licensing Act 2003 will also form part of the licence issued.

Counsel for the applicant company explained the plans, and the Sub-Committee considered that all aspects were satisfactory. The Sub-Committee took into account the written representations made; these were covered by the agreed conditions. The Sub-Committee deliberated the operating schedule put forward by the applicant and the likely impact of the application, including the agreed conditions, and concluded that by granting this application, the four licensing objectives contained in the Act will be properly promoted.

In reaching this decision, the Sub-Committee has given due consideration to the City Council's Statement of Licensing Policy, the Guidance issued under Section 182 of the Licensing Act 2003 by the Secretary of State, the application for a premises licence, the written representations received and the submissions made at the hearing by counsel for the applicant company and those making representations.

All parties are reminded that under the provisions contained within Schedule 5 to the Licensing Act 2003, there is the right of appeal against the decision of the Licensing Authority to the Magistrates' Court, such an appeal to be made within twenty-one days of the date of notification of the decision.

The Chairman introduced the Members and officers present and the Chair asked if there were any preliminary points for the Sub-Committee to consider.

The Chairman then explained the hearing procedure prior to inviting the Licensing Officer, Bhapinder Nandhra to outline the report.

Afterwards, the Chairman invited the applicant or their representative to outline their application, at which stage Patrick Burke made the following points: -

- a) That the premises previously operated as a hardware essential goods store.
- b) The applicant knew the area and the local residents well and had previous experience working in pubs and nightclubs in London and France.
- c) The applicants Nephew had experience running off licences.
- d) The road the premises was situated on was busy and commercial, there were other shops such as Aldi close by.
- e) His client had already spent time and money refurbishing the shop and making it look nice.
- f) The applicant wanted to specialise in quality goods; no cheap 2 for 1 offers. He would be selling quality beers, wines and spirits.
- g) The objection at Appendix 1 suggested that the new licence would increase public nuisance, drinking culture and the impact on school children. However, there was no evidence and no Responsible Authorities had made any objections to the application.

#### Licensing Sub-Committee B - 30 March 2021

- h) The objection at Appendix 2 also raised concerns of drunken behaviour and an incident at another store which was not relevant to this application.
- i) There was also reference to drug dealing, however West Midlands Police had made no objection.
- j) That the objections were based on speculation and cited the case of <u>Daniel</u> <u>Thwaites plc v Wirral Borough Magistrates' Court [2008] EWHC 838 (Admin).</u>
- k) That there were 5 objections from residents, yet no objections from any of the responsible authorities.
- I) His client was looking to open a quality premises selling quality goods.
- m) There were about 30 houses and none of those residents had objected.

In answer to questions from Members, Patrick Burke, on behalf of the applicant made the following points: -

- a) They did not reach out to objectors because there were more than 4 and therefore, it was not something they would usually do.
- b) CCTV would cover the front of the shop and the inside too.
- c) That it was not the kind of premises which would sell super strength, cheap beers. The alcohol would not be the type of products that would attract street drinkers.

The Chairman invited Mrs Idris to make her submission, at which stage Mrs Idris made the following points: -

- a) That she had been living in the area for 15 years and although it was a beautiful area there were issues with men drinking. It wasn't good for her kids.
- b) That there were already 7 off licences in the area and they didn't need another one.
- c) She was scared to go out with the children. One of her children had special needs and it wasn't good for the children.
- d) No matter what hours were applied for, it would not make them feel safe. There were drunks and junkies everywhere.

The Chairman invited the applicant and their representative to make a closing submission, at which stage Patrick Burke on behalf of the applicant made the following points: -

His client lived in the area and knew it well and although there were 5 objections but none of which were from anyone living on that street.

- That his client was very brave to take this business on given the current circumstances with the Covid-19 Pandemic.
- The premises was not going to be a normal 'Lifestyle Express' it was going to be a quality off licence selling premium products.
- > There were no objections from any responsible authorities.

The Chairman invited Mrs Idris to make a closing submission, at which stage she made the following points: -

- She was scared and felt she had to ask her husband to go to the shop with her.
- She didn't feel safe taking the children out either.

At this stage the meeting was adjourned in order for the Sub Committee to make a decision and all parties left the Teams meeting. The Members, Committee Lawyer and Committee Manager conducted the deliberations in private and decision of the Sub-Committee was sent out to all parties as follows: -

#### 4/300321 **<u>RESOLVED</u>**:-

That the application by World Wine Store Limited for a premises licence in respect of Wine O'Clock, 4 Silver Street, Kings Heath, Birmingham B14 7QU, **BE GRANTED** with the hours of operation to be from 09.00 hours to 22.00 hours daily. Those matters detailed in the operating schedule and the relevant mandatory conditions under the Licensing Act 2003 will also form part of the licence issued.

The Sub-Committee deliberated the operating schedule put forward by the applicant company, and the likely impact of the application - in particular the offer to shorten the operating hours. The Sub-Committee concluded that by granting this application, the four licensing objectives contained in the Act will be properly promoted.

The director of the applicant company explained via his representative that he was experienced in the licensed trade – pubs and clubs in France, and restaurants in London. He lived locally and knew the area well, running a mobile phone shop round the corner from the instant premises. He had invested money in the premises, and had made arrangements for his nephew to assist him in the running of the shop.

Members carefully considered the representations made by other persons, namely local residents (one of whom addressed the Sub-Committee directly in the meeting), but were not convinced that there was an evidential and causal link between the issues raised

and the effect on the licensing objectives. The representations related to street drinking and other antisocial behaviour, which were perhaps attributable to existing premises in the area. Other issues, such as drug use, were not of great relevance to an application to operate as an off-licence. It was not likely that a carefully-managed new premises would add significantly to these problems.

The shop was based in the busy commercial area of Silver Street, which served thousands of residents in the surrounding district. The plan was to specialise in quality wines, beers and spirits – certainly not cheap high-strength alcohol, as favoured by street drinkers.

Those making representations were keen to state that to grant a further licence in the area would have a negative impact on the licensing objectives, but the applicant company's representative cited the case of <u>Daniel Thwaites plc v Wirral Borough Magistrates'</u> <u>Court [2008] EWHC 838 (Admin)</u> in urging the Sub-Committee not to be unduly influenced by speculative representations. The submissions made by the applicant company's representative had made clear that there was no reason to think that either the operation, or the licence holder, would not be capable of upholding the licensing objectives. Moreover, the Sub-Committee noted that no representations had been made by West Midlands Police, and as the applicant company's representative pointed out, no resident of Silver Street had objected either.

In reaching this decision, the Sub-Committee has given due consideration to the City Council's Statement of Licensing Policy, the Guidance issued under s182 of the Licensing Act 2003 by the Secretary of State, the application for a premises licence, the written representations received and the submissions made at the hearing by the applicant company via its representative, and by those making representations.

All parties are reminded that under the provisions contained within Schedule 5 to the Licensing Act 2003, there is the right of appeal against the decision of the Licensing Authority to the Magistrates' Court, such an appeal to be made within twenty-one days of the date of notification of the decision.

The Chairman introduced the Members and officers present and the Chair asked if there were any preliminary points for the Sub-Committee to consider.

The Chairman then explained the hearing procedure prior to inviting the Licensing Officer, Bhapinder Nandhra to outline the report.

Afterwards, the Chairman invited the applicant or their representative to outline their application, at which stage Patrick Burke made the following points: -

- a) That the previous owners of the business sold it and then transferred the licence.
- b) The premises was situated in a parade of six shops. There was a wine shop, kebab shop, news agents, doctor's surgery and an empty shop.
- c) His client had taken over the lease, he had a wealth of experience and had worked in several shops around Birmingham.
- d) There had never been any issues in any of the shops his client had worked in.
- e) There wasn't any objections from any responsible authorities.
- f) The objection at appendix 1 expressed concerns regarding the opening time of 7am, however the shop was already open from 7am daily. The hostels in the area were backpacker hostels.

- g) Appendix 2 detailed concerns about drug dealing, drug consumption and rubbish. However, they had committed to providing adequate bins for rubbish. There was also a concern about loitering, but there was no evidence of this, or any objection from any responsible authorities.
- h) Appendix 3 suggested crime was on the up, yet there was no objection from West Midlands Police.
- i) The objections at Appendix 4, 5 and 6 should be disregarded as they weren't applicable, they were based on competition which was not a consideration under the Licensing regime.
- Appendix 7 was concerned with protecting children from harm but again there was no evidence to support that and no objections from responsible authorities.
- k) The petition was instigated by the shop next door and therefore they were concerned that the petition was not based on the licensing objectives.
- I) Appendix 8 and 9 raised concerns of anti-social behaviour and public nuisance, however again there was no evidence to support the concerns.
- m) In conclusion Mr Burke stated that the objections were based on speculation and cited the case of <u>Daniel Thwaites plc v Wirral Borough Magistrates' Court</u> [2008] EWHC 838 (Admin).

In answer to questions from Members, Patrick Burke, on behalf of the applicant made the following points: -

- a) The premises was already operating 7am-10pm and they were applying for a licence to match the current opening hours. However, they would amend the licensable hours to 8am.
- b) The premises would be selling a standard selection of alcohol, much the same as the shop next door.
- c) The cheapest bottle of wine would be about £5.00.
- d) A 4 pack of Stella would be £6.49 and Carling £4.99.
- e) His client had worked in premises in Rubery and Cotteridge.
- f) The premises had been refurbished.
- g) His client had installed additional CCTV both inside and outside the premises. There would be a challenge 25 policy, refusals book, and they would provide staff training.
- h) That they understood the residents concerns but West Midlands Police hadn't raised any issues with the application.

The Chairman invited Sandra Drummond to make her submission, at which stage Sandra Drummond made the following points: -

- a) That the residents in the area didn't think the licence was needed. It wouldn't benefit them in anyway and they were trying to build a community.
- b) That the applicant didn't live in the area and didn't have to witness what was going on.
- c) That the refurb wasn't complete, there was still work to do inside and outside.
- d) That Cotteridge was a different demographic and therefore it wouldn't be fair to compare them.
- e) The premises opened at 12noon, not 8am.
- f) That she wanted to start a resident's association. The community was working together for better.
- g) There was a lot of problems in the area and people suffering from mental health issues. A second off licence would not help or benefit the community.

At this stage in the meeting, Lorna Harris was invited to make her case and made the following points: -

- a) The hostels were not for backpackers.
- b) She was a counsellor and knew the issues in the area.
- c) Mothers were scared for their children's safety.
- d) There was alcohol all over the place.
- e) The other off licence shut at 3pm on a Sunday, and the owner had respect for the local community.
- f) She had grandchildren and wanted them to have freedom.
- g) That no one had petitioned for an alcohol shop, a meat shop would be better.

The Chairman invited Sarah Rumble to make her submissions, at which stage she made the following points: -

- a) That she had 3 children growing up here and didn't see the need for another off licence.
- b) The other off licence in the area opened at reasonable times and respected the residents.

- c) That it wasn't right opening an off licence that early in the morning when children were going to school.
- d) That she was angry at the applicant for trying to open another off licence.
- e) That the area could do with the meat shop that sold lamb and pork.

The Chairman invited Sarah Rumble to make a closing submission and as such she made the following points: -

- > That she had nothing else to say, Lorna and Sandra had said everything.
- The area was becoming lovely, she had lived here for 23 years and she felt there wasn't a need for another off licence.

The Chairman invited Sandra Drummond to make her closing submission, at which point she made the following points: -

- > That they didn't need another off licence.
- > They were trying to build a community.
- > They wanted to move forwards not backwards.

The Chairman invited Lorna Harris to make her closing submission and as such she made the following points: -

- That it had taken a lifetime to build anything of worth and they wanted to continue building the community up.
- > Another off licence would destroy it.

The Chairman invited the applicant and their representative to make a closing submission, at which stage Patrick Burke on behalf of the applicant made the following points: -

- His client had a wealth of experience in this line of business and had worked in other shops.
- > There were no representations from any of the responsible authorities.
- That his client was not looking to open an off licence, it was a store which included groceries and meat.
- That it was a brave thing to do opening a business with everything going on in the world currently.
- > That they were refurbishing the shop.

At this stage the meeting was adjourned in order for the Sub Committee to make a decision and all parties left the Teams meeting. The Members, Committee Lawyer and Committee Manager conducted the deliberations in private and decision of the Sub-Committee was sent out to all parties as follows: -

#### 4/060421 **RESOLVED**:-

That the application by Maninder Singh Khurana for a premises licence in respect of Church Road Convenience Store, 12 - 14 Church Road, Aston, Birmingham B6 5UP, **BE GRANTED** with the hours of operation to be from 08.00 hours to 22.00 hours daily. Those matters detailed in the operating schedule and the relevant mandatory conditions under the Licensing Act 2003 will also form part of the licence issued.

The Sub-Committee deliberated the operating schedule put forward by the applicant company, and the likely impact of the application - in particular the offer to shorten the operating hours. The Sub-Committee concluded that by granting this application, the four licensing objectives contained in the Act will be properly promoted.

The director of the applicant company explained via his representative that he was experienced in the licensed trade – as a manager and staff member in retail premises. He was assisted by a business partner. He had invested money in the premises, and had made various improvements such as the installation of additional CCTV cameras and lighting inside and outside the shop.

Members carefully considered the representations made by other persons, namely local residents (three of whom addressed the Sub-Committee directly in the meeting), but were not convinced that there was an evidential and causal link between the issues raised and the effect on the licensing objectives. The representations related to a risk of increased antisocial behaviour and crime, which the residents felt were associated with a hostel nearby, but it was not likely that a carefully-managed new premises would add significantly to these problems. The plan was to offer alcohol at the recommended retail price, rather than offering cutprice promotions.

Those making representations were keen to state that to grant a further licence in the area would have a negative impact on the licensing objectives, but the applicant company's representative cited the case of <u>Daniel Thwaites plc v Wirral Borough Magistrates'</u> <u>Court [2008] EWHC 838 (Admin)</u> in urging the Sub-Committee not to be unduly influenced by speculative representations. The submissions made by the applicant company's representative had made clear that there was no reason to think that either the operation, or the licence holder, would not be capable of upholding

the licensing objectives. Moreover, the Sub-Committee noted that no representations had been made by West Midlands Police.

In reaching this decision, the Sub-Committee has given due consideration to the City Council's Statement of Licensing Policy, the Guidance issued under s182 of the Licensing Act 2003 by the Secretary of State, the application for a premises licence, the written representations received and the submissions made at the hearing by the applicant via his representative, and by those making representations.

All parties are reminded that under the provisions contained within Schedule 5 to the Licensing Act 2003, there is the right of appeal against the decision of the Licensing Authority to the Magistrates' Court, such an appeal to be made within twenty-one days of the date of notification of the decision.

Residents and business owners are vey concerned about their safety and the safety of their businesses.


As you can see from the pictures the business is already in breach of licensing law.







I write in reference to the above application made by European & Asian Mini Market for the sale of alcohol for an off licence premises licence.



1.5 A CCTV log will be completed on a weekly basis to record all elements of the CCTV System is maintained in good working order and recordings date and time stamped.

1.6 All staff shall be trained in the operation of the CCTV system to ensure rapid data retrieval & downloads of footage can be provided to the Police & the Local Authority Officer upon reasonable request in accordance with the Data Protection Act.

1.7 CCTV shall be continually recording during licensable hours

1.8 In the event of a failure of the CCTV system for any reason, a record of the failure will be recorded in the premises log and immediate steps will be made to rectify the problem.

#### b) The prevention of crime and disorder

2. Incident / Refusals Register

**2.1** An incident log must be kept at the premises. Log records will be retained for a period of 12 months from the date it occurred. It will be made immediately available on request to an 'authorised person' (as defined by section 13 of the Licensing Act 2003), an authorised trading standards officer or the police, and must record the following;

(a) All crimes reported to the premises (where relevant to the licensing objectives)

(b) Any incidents of disorder

3. When the designated premises supervisor is not on duty, a contact telephone number will be available at all times.

4. All spirits will be stored and sold behind the counter

5. Roller shutters are in operation at the front of the premises

6. The premises will have a written policy in relation to drunkenness. Premises should not admit persons who are visibly intoxicated and staff should be trained regarding responsible alcohol sales, identifying drunkenness and preventing alcohol sales to them.

#### d) The prevention of public nuisance

10. A written register of refusals will be kept including a description of the people who have been unable to provide required identification to prove their age. Such records shall be kept for a period of 12 months and will be collected by the designated premises supervisor and produced to the police or an 'authorised person' (as defined by section 13 of the licensing act 2003) or an authorised trading standards officer the local authority/council on demand.

11. All staff engaged in the sale of alcohol to be trained in Challenge 25. Training records shall be kept on the premises and produced to the police or an 'authorised person' (as defined by section 13 of the licensing act 2003) or an authorised trading standards officer of the local authority/council on demand.

12. Proxy signs will be on display warning adults about the law surrounding buying alcohol for children

13. Staff will monitor the outside area to identify any potential proxy purchasing concerns.

#### 14. Challenge 25

**14.1** The premises shall operate a Challenge 25 policy. Such policy shall be written down and kept at the premises. The policy shall be produced on demand of the police or an 'authorised person'

**14.2** Prominent, clear and legible Challenge 25 signage shall also be displayed at all entrances to the premises as well as at, at least one location behind any counter advertising the scheme operated.





### **Statement of Truth**

My name is Nabaz Ali-Pour and I am the owner of a convenience store called European and Asian Mini Market, at 290 Alum Rock Road, Birmingham, B8 3DD.

I applied for a premises Licence on the 8<sup>th</sup> March 2021 which was accepted by Birmingham City Council and I was informed by my agent, Mr Tony Clarke that the final date for representations and objections was the 5<sup>th</sup> April 2021.

The Premises Licence application notice was displayed as per the guidelines on the 9<sup>th</sup> March and photographic evidence was then sent to Birmingham City Council on the same day. The notice was checked daily and I removed it on the 6<sup>th</sup> April 2021.

I applied for the Temporary Event Notices, for the following Dates: Tuesday 23<sup>rd</sup> March – Sunday 28<sup>th</sup> March and Tuesday 30<sup>th</sup> March – Sunday 4<sup>th</sup> April. These were accepted, although, I decided not to sell any alcohol at all. I have kept CCTV recordings for these periods which can be released at the Magistrate's Court as evidence if required.

My shop signage was installed on the 27<sup>th</sup> March 2021. The parts of the signage that refer to 'Off Licence' or 'Alcohol' were then covered up on the 5<sup>th</sup> April 2021 when it became apparent that there were relevant objections to my application. They are still covered up to this day.

On the 29<sup>th</sup> March 2021 at 19:09 three Asian men came into my shop, I did not know them. They approached me (as there was only me and a friend in the shop at the time) and started to tell me that it is against Sharia law to sell alcohol, and it is 'Haram'. I tried to explain that I have a right under UK legislation to sell alcohol if I wish and they then told me that I cannot sell alcohol in this area and I must stop now. I felt intimidated as I never met these men before and I didn't expect to be threatened in this way. This incident lasted only 2 minutes and I have CCTV footage of the incident if I am requested at a later date to show it. I now know one the men to be Mr who owns the travel agent at

Alum Rock Road. One of the other men works at this shop and the third man does not live or work locally as far as I know.

My agent, Mr Clarke, informed me that I should try to talk to the objectors but I didn't want to because I was scared of reprisals and causing more trouble in the local area. I firmly believe all of the objector's real reasons for their objection is because of their religious beliefs. Further to this-

I now know that Mr is a friend of Mr of because I have been told this by some of the local residents and I have also seen them talking myself outside each other's shops many times since my shop has been open, and Cllr Idrees also has his 'Advice Surgeries' from inside the same shop as whom I believe is one of the objectors.

We write on behalf of our client who is the applicant Mr Nabaz Ali-Pour for the above application.

Mr Ali-Pour is quite distressed regarding several parodies and distortions contained in your 'Letters of Objection'.

There are 3 incidents that have happened involving my client and other parties during the application process and this letter is to propose any or all of the named parties an opportunity to seriously consider the facts contained in your statements prior to the hearing.

In line with the Licensing Act 2003 (Hearings) (Amendment) Regulations 2014, your statements have been submitted within the legal time frame and although we can all openly discuss your comments at the hearing, you will not legally be permitted to add any additional facts or information, however you can withdraw your statements which must be in writing before the hearing date.

This letter will be submitted as part of our supporting evidence prior to the hearing.

Should these letters of objection not be withdrawn before the hearing, then we will take this opportunity to discuss their contents and ask certain investigative questions in their entirety.

Your statements contain some quite serious and reckless false allegations and claims, of which if not challenged and corrected could put my client in prison for up to 6 months and an unlimited fine. It also evidently appears that at no time did anyone try to examine or investigate any of these false allegations prior to their submission to the Authority.

Our client has also been subjected 3 times to forms of intimidation.

The first time was when 3 Asian gentlemen entered his shop shortly after opening and on a 2 more subsequent occasions involved a meeting with Mr Ali-Pour and local residents and local businessmen.

The narrative from the other parties during these meetings made it quite apparent that my client should not and cannot sell alcohol due to Sharia Law and religious beliefs.

These incidents were all recorded and the footage retained.

My client has retained the visual and audio evidence and a 'Statement of Truth' signed by Mr Ali-Pour will be submitted to the Licensing Office to be produced to the Sub-committee prior to next Tuesday.

Some of these false and dangerous allegations have been now been expressed in writing by yourselves with no supporting evidence.

These statements will be going into the public domain at the hearing and after they will be published on the Birmingham City Council website and my client will be advised of a possible intention of taking formal legal action of defamation at a later date.

May we also advise yourselves of the following. s158 of the Licensing Act 2003

'a person commits an offence if he knowingly **knowingly or recklessly** makes a false statement in or connection (1)(a) an application for the grant of a premises licence

(2) For the purposes of subsection (1) a person is to be treated as making a **false statement** if he **produces**, furnishes, signs or **otherwise makes use of a document that contains a false statement**.

(3)A person guilty of an offence under this section is liable on summary conviction to a fine not exceeding level 5 ( $\pm$ 5000) on the standard scale.

A similar statement was also affirmed in the last paragraph of the light blue Public Notice that our client prominently displayed immediately outside his premises for 28 consecutive days with contact numbers for the Licensing Office where legal advice could have been obtained.

Therefore we can safely assume that any objectors had sufficient time to read, seek further legal advice and understand fully the application and the above legal statement.

We also consider that parts of your statements contain vexatious, frivolous or irrelevant statements and we will be asking the subcommittee to disregarded them.

As part of an Objectors responsibility prior to submission of an Objection is to carefully study the contents of the Operating Schedule, we trust all the Objectors went through this process.

The same Operating Schedule was submitted to the Licensing Authority and forwarded to the police and the other 8 Responsible Authorities. We can advise you that all parties have accepted and approved our application in full.

The Responsible Authorities are proficient in their own area of expertise. The police are the experts in Crime & Disorder and would have carefully studied the crime figures and knowledge of the area before making their decision.

The panel rely on the police for their advice and intelligence and will note their absence at the hearing.

#### JMC Licensing Consultants <sup>4</sup> Warrington Office

The police contacted our office to discuss the application and we agreed 2 additional conditions and a further condition with the Officer from the Responsible Authority.

This confirms that all parties are now fully satisfied that our clients application will 'not' undermine any of the Licensing Objectives mainly the Prevention of Crime, the Prevention of Public Nuisance and finally the Protection of Children from Harm.

All the conditions offered by our clients fully support all of the 4 Licensing Objectives.

Mr Ali-Pour has also retained the CCTV footage for a full 24 hours of each day from the day he opened until now for evidential reasons to prove that no alcohol has ever been sold from the shop even though he did have the necessary permissions in place.

On the 5<sup>th</sup> April Mr Ali-Pour covered up all photographs and wording relating to alcohol, which was the last day he was permitted to sell alcohol and we have also submitted photographic evidence to support this fact.

We would further like to add that there is no such idiom known as a 'planning licence'.

Finally we also advise all parties that should our client's application be refused, an Appeal against this decision will be submitted to the Magistrates Courts where your attendance will be required to support the contents of your Letter of Objections.

My client has committed no crimes and he has done no wrong.

Good afternoon Cllrs Khan and Idrees / 3 other Objectors

Re: Application for a Premises Licence 290 Alum Rock Road, Birmingham, B8 3DD Hearing Tuesday 4<sup>th</sup> May 2021 – 10.00

We write on behalf of our client who is the applicant Mr Nabaz Ali-Pour for the above application.

Mr Ali-Pour is quite distressed regarding several parodies and distortions contained in your 'Letters of Objection'.

There are 3 incidents that have happened involving my client and other parties during the application process and this letter is to propose any or all of the named parties an opportunity to seriously consider the facts contained in your statements prior to the hearing.

In line with the Licensing Act 2003 (Hearings) (Amendment) Regulations 2014, your statements have been submitted within the legal time frame and although we can all openly discuss your comments at the hearing, you will not legally be permitted to add any additional facts or information, however you can withdraw your statements which must be in writing before the hearing date.

This letter will be submitted as part of our supporting evidence prior to the hearing.

Should these letters of objection not be withdrawn before the hearing, then we will take this opportunity to discuss their contents and ask certain investigative questions in their entirety.

Your statements contain some quite serious and reckless false allegations and claims, of which if not challenged and corrected could put my client in prison for up to 6 months and an unlimited fine. It also evidently appears that at no time did anyone try to examine or investigate any of these false allegations prior to their submission to the Authority.

Our client has also been subjected 3 times to forms of intimidation.

The first time was when 3 Asian gentlemen entered his shop shortly after opening and on a 2 more subsequent occasions involved a meeting with Mr Ali-Pour and local residents and local businessmen.

The narrative from the other parties during these meetings made it quite apparent that my client should not and cannot sell alcohol due to Sharia Law and religious beliefs.

These incidents were all recorded and the footage retained.

My client has retained the visual and audio evidence and a 'Statement of Truth' signed by Mr Ali-Pour will be submitted to the Licensing Office to be produced to the Sub-committee prior to next Tuesday.

Some of these false and dangerous allegations have been now been expressed in writing by yourselves with no supporting evidence.

These statements will be going into the public domain at the hearing and after they will be published on the Birmingham City Council website and my client will be advised of a possible intention of taking formal legal action of defamation at a later date.

May we also advise yourselves of the following. s158 of the Licensing Act 2003

'a person commits an offence if he knowingly **knowingly or recklessly** makes a false statement in or connection (1)(a) an application for the grant of a premises licence

(2) For the purposes of subsection (1) a person is to be treated as making a **false statement** if he **produces**, furnishes, signs or **otherwise makes use of a document that contains a false statement**.

(3)A person guilty of an offence under this section is liable on summary conviction to a fine not exceeding level 5 ( $\pm$ 5000) on the standard scale.

A similar statement was also affirmed in the last paragraph of the light blue Public Notice that our client prominently displayed immediately outside his premises for 28 consecutive days with contact numbers for the Licensing Office where legal advice could have been obtained.

Therefore we can safely assume that any objectors had sufficient time to read, seek further legal advice and understand fully the application and the above legal statement.

We also consider that parts of your statements contain vexatious, frivolous or irrelevant statements and we will be asking the subcommittee to disregarded them.

As part of an Objectors responsibility prior to submission of an Objection is to carefully study the contents of the Operating Schedule, we trust all the Objectors went through this process.

The same Operating Schedule was submitted to the Licensing Authority and forwarded to the police and the other 8 Responsible Authorities. We can advise you that all parties have accepted and approved our application in full.

The Responsible Authorities are proficient in their own area of expertise. The police are the experts in Crime & Disorder and would have carefully studied the crime figures and knowledge of the area before making their decision.

The panel rely on the police for their advice and intelligence and will note their absence at the hearing.

The police contacted our office to discuss the application and we agreed 2 additional conditions and a further condition with the Officer from the Responsible Authority.

All the conditions offered by our clients fully support all of the 4 Licensing Objectives.





Dear Mr David Kennedy AND Councillor Mohammed Idrees.

I write further to our Microsoft team meeting at 10:00am on 4th May 2021. Contents of which have been noted here within.

I am a business resident at Alum rock Road, Birmingham B8 3DD. I have objected to the grant of the off license, as I believe this will cause nuisance and disruption to the peace of all the residence.

Please note, as residence we was not given any notice by the local licensing committee of the application made by the applicant. This only came to my attention when I read the sign board displayed at 290 Alum Rock Road, Birmingham, B8 3DD.

Furthermore, we only received the disclosure by email 10 minutes prior to the hearing, not giving the complainants a fair time scale to examine and review the evidence provided by the applicant and his representatives.

Moreover, I have since made number of enquiries and still await for further witness statements by the persons the applicant states in his disclosure of accepting and supporting his application. I have now spoken to a specific person the applicants mentions in his disclosure, who confirms that he has not signed any document to accept or support the applicants license.

The applicant has provided names and address of customers supporting his application. I believe this to be irrelevant as the people that will be affected in this matter are the local and immediate residence not his customers. The residence have experienced vehicles parking up and drinking and police have failed to response or take action by allowing a license this will cause further issues for the neighbouring residence with people parked up outside their residential homes and drinking in their cars.

I believe this is a very serious offence for which the applicant may be prosecuted for misusing and fraudulently signing documents. I am in the process of gathering further witness statements from the residence who all want to participate in the hearing. Furthermore, Mr (complainant) a resident of Alum Rock Road, Birmingham, B8 is currently is in a religious quarantine for 8 days (I'tikāf is an Islamic practice consisting of a period of staying in a mosque for a certain number of days, devoting oneself to worship during these days and staying away from worldly affairs.)

Mr is a key witness to the hearing and can contribute substantial evidence in the above matter. He has further documentation in support of our objection and a

signed partition from neighbouring residence and local community strongly objecting to the granting of the off license.

It is only fair under Article 6, right to a fair and public hearing for the residence to get a fair chance to represent themselves at a hearing and to put their views and concerns to the committee and chair persons, as they have previously been ignored and no communication was ever made by the relevant department to notify them of such application.

The applicant has attended my and Mr premises, the applicants has been asking local business about us, he has made it clear that he will obtain the license either way.

I would like to request the honourable chairpersons to adjourn the scheduled hearing on 5th May 2021 at 11:30am as we require further time to compile witness statements and produce further evidence in support of our objection and represent our concerns to rebut the applicants evidence.

I would also like to emphasis that a false statement and evidence has been provided by the applicant, which will now be a matter for the West Midlands Police to investigate, the applicant may also find himself subject to criminal proceedings.

I can not be present at the re-scheduled meeting which will take place on 5th May 2021 at 11:30am due to work commitment. I would like to request an adjournment of this hearing and to re-schedule a further hearing which I can attend. Please note, I spoke to Mr David Kennedy of my concerns who advised me that "I am lucky that the chairpersons have allowed the adjournment until 11:30am for 5th May 2021", usually the adjournment is only 2 hours"... that this is not your in normal hearings", which I found to be some what strange as all hearing have a legal framework and code of ethics that should be followed and adhered by the local authority.
