The Chairman introduced the Members and officers present then explained the hearing procedure prior to inviting the Licensing Officer, Bhapinder Nandhra to outline the report.

Afterwards, the Chairman invited the applicant's representative to make their submission. At which stage Mijanur Rahman, made the following points on behalf of the applicant: -

- a) That the application was for a convenience store and off licence.
- b) The representation received in email format highlighted the hours of trading as the main issue, due to noise nuisance. They had responded to the email and tried to outline steps they could take to ensure noise was controlled and also pointed out the conditions agreed with Licensing Enforcement (LE) and West Midlands Police (WMP). Unfortunately, the objector did not withdraw their objection.
- c) The shop was positioned within a 'ring' of shops, some of which were food premises; pizza shop, café, and a fish and chip shop. Some of those premises had licences until midnight and the community centre had a licence until 0100 hours everyday. There was also a late-night Pharmacy within the ring of shops.
- d) That the application was in keeping with the other shops in the area.

Licensing Sub-Committee C - 15 July 2020.

- e) The applicant had another 24-hour licence and had never had any issues or complaints.
- f) The store was marketed as a mini market a convenience type store.
- g) People would be purchasing eggs, milk, bread and alcohol.
- h) They had agreed the conditions with LE and WMP.

In summing up Mr Rahman, on behalf of the applicant made the following points:

- That his client was an experienced licence holder who currently held a 24hour licence. He was also family man and it would be a family run business.
- They had considered reducing the hours, but they were in keeping with the area and therefore felt the hours were necessary.

At this stage the meeting was adjourned in order for the Sub Committee to make a decision and all parties left the meeting. The Members, Committee Lawyer and Committee Manager conducted the deliberations in private and decision of the Sub-Committee was sent out to all parties as follows: -

5/150720 **RESOLVED**:-

That the application by Tesfit Meles for a premises licence in respect of Mini Supermarket, 121 Witton Lodge Road, Perry Common, Birmingham, B23 5JD be granted.

Those matters detailed in the operating schedule, and the relevant mandatory conditions under the Licensing Act 2003, will form part of the licence issued, together with those additional conditions which were agreed by email in advance of the meeting (and reproduced in the Report) following discussions between the applicant, West Midlands Police and Licensing Enforcement, namely:

- If for any reason the CCTV hard drive needs to be replaced or repaired the previous/ old hard drive will be kept on site for a minimum of 28 days and made immediately available to any of the responsible authorities on request
- Cameras outside the premises are required to be able to still function in conditions of reduced lighting in order to be able to provide recordings of an evidential quality
- All staff with the exception or personal licence holders will receive training in their responsibilities under the Licensing Act 2003, the licensing objectives and the Challenge 25 policy
- A record of training will be maintained and this will be signed by both the trainer and trainee. The training will be documented, kept on site and produced upon request to an authorised person. It will be

refreshed every 6 months. No staff will be permitted to work in the premises if they have not completed this training

- A sales refusals book will be kept on site and completed by the member of staff each time they refuse a sale of an age restricted product. The refusals book will be signed off by the DPS every month
- Single cans or bottles of less than 75 ml of beers, ciders and alcopops, and plastic cups to accompany purchases of alcohol, are not to be sold
- A notice will be displayed at the exit of the premises requesting customers to leave quietly and respect the local neighbourhood

The Sub Committee deliberated the operating schedule put forward by the applicant and the likely impact of the application, including the agreed conditions, and concluded that by granting this application, the four licensing objectives contained in the Act will be properly promoted.

Members carefully considered the representations made by another person, who submitted a written objection, but were not convinced that there was an evidential and causal link between the issues raised and the effect on the licensing objectives. Other licensed premises in the area already operated to similar, or even later, hours. The applicant was an experienced person who currently held a 24 hour licence elsewhere, and had been operating at that premises without problems. It would be a family-run convenience store with 'off' sales of alcohol. All in all, the Sub-Committee was satisfied that the applicant had sufficient experience to manage such a shop in the Witton Lodge Road area responsibly.

The Sub-Committee considers the conditions agreed between the applicant, West Midlands Police and Licensing Enforcement to be appropriate, reasonable and proportionate to address concerns raised by the objector.

In reaching this decision, the Sub-Committee has given due consideration to the City Council's Statement of Licensing Policy, the Guidance issued under section 182 of the Licensing Act 2003 by the Secretary of State, the information in the application, the written representations received and the submissions made at the hearing by the applicant via his representative.

All parties are reminded that under the provisions contained within Schedule 5 to the Licensing Act 2003, there is the right of appeal against the decision of the Licensing Authority to the Magistrates' Court, such an appeal to be made within twenty-one days of the date of notification of the decision.

Dear Licensing

We wish to object to the licence application made for the above premises which proposes the sale of alcohol on a 24 hour basis due to its proposed operation not being compliant with the Licensing Objectives – namely the Prevention of Crime & Disorder and Prevention of Public Nuisance.

Erdington High Street already suffers from street drinking and alcohol-related ASB and this is particularly significant at the Six Ways end. We receive frequent complaints about street drinkers congregating during the day outside Dixons and Domino's Pizza, and so the provision of another premises selling alcohol is a serious concern – especially where is it proposed to be on a 24 hour basis. Currently there is only one off-licence open beyond 11pm and this causes significant disruption already with street drinking and ASB. The addition of another late night premises will exacerbate this situation further and mean that the premises would operate contrary to the Licensing Objectives.

However, if the applicant was willing to consider revised hours for the sale of alcohol and agree to the following conditions, then we would be willing to withdraw our representation:

- No alcohol to be served to customers who are believed to be street drinkers or are believed to consume alcohol within the vicinity of the premises and High Street
- No alcohol only sales
- Any street drinkers who congregate within the vicinity of the store will be moved on by staff, or if needed reported to West Midlands Police
- Sales of beers, lagers and ciders with an ABV percentage of above 6% is prohibited
- No more than 20% of the surface area of the public area of the premises will be used for the display of alcohol
- A refusals register will be kept on the premises
- Staff will be trained as to their obligations for the sale of alcohol and this will be refreshed on an annual basis or following any changes to the Licensing Act 2003.

We are of the view that the above conditions will help to ensure compliance with the Licensing Objectives and would have a minimal impact for both the premises and the surrounding area. If the applicant is not willing to agree to these conditions, then we do object to the application in full and wish to put forward our case to a Licensing Sub-committee. The applicant or their agent is welcome to make contact with us to discuss our concerns.

3. Any recording will be retained and stored in a suitable and secure manner for a minimum of 31 days and shall be made available, subject to compliance with Data Protection legislation, to the police for inspection on request.

4. The precise positions of the camera may be agreed, subject to compliance with Data Protection legislation, with the police from time to time.

5. The system will display, on any recording, the correct time and date of the recording.

6. The CCTV system will be maintained and fully operational throughout the hours that the premises are open for any licensable activity.

7. There will be no sales/supplies of beer, lager or cider with an ABV over 6%.

c) Public safety

There will at all times be adequate levels of staff maintained at the premises. Such staff levels will be disclosed, on request, to the licensing authority and police.

No supply of alcohol may be made under the premises licence (a) at a time when there is no designated premises supervisor in respect of the premises licence, or (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

Every retail sale or supply of alcohol made under this licence must be made or authorised by a person who holds a personal licence.

The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol. The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy. The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either— (a) a holographic mark, or (b) an ultraviolet feature.

(1) A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price. (2) In this condition: - (a) "permitted price" is the price found by applying the formula $P = D + (D \times V)$, where- (i) P is the permitted price, (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol; (b) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979; (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence- (i) the holder of the premises licence, (ii) the designated premises supervisor (if any) in respect of such a licence, or (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence; (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994. (3) Where the permitted price would not be a whole number of pennies, the permitted price shall be taken to be the price rounded up to the nearest penny. (4) Where the permitted price on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax, the permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

Annex 2 – Conditions consistent with operating schedule

2a) General conditions consistent with the operating schedule

No enforceable conditions identified from operating schedule.

2b) Conditions consistent with, and to promote the prevention of crime and disorder

The Licence Holder shall install and maintain a new CCTV system, or will maintain the existing system so that it is fit for the purpose.

The Licence Holder shall ensure the CCTV system will be capable of producing immediate copies of recordings on site. The copies of recordings will be recorded on good quality video tape or digitally on to a CD/DVD or other equivalent medium.

Any recording shall be retained and stored in a suitable and secure manner for a minimum of 28 days and shall be made available, subject to compliance from Data Protection Legislation, to the Police for inspection on request.

All cashiers will be instructed, through training, that a sale shall not be made unless the evidence is produced. Prominent notices will be displayed in the store advising customers that they may be asked to provide evidence of age.
