Local Innovations Fund Update -Councillor Sharpe

Councillor Sharpe stated that Cabinet met in December to discuss the Tyburn L.I.F project which was the first that the City had received and gave it's full approval. The comments from the Cabinet were that the project was exactly what had been previously hoped would come from the initiative and Tyburn Ward had "set the bar to a very high level for the rest of the City to work to". Councillor Sharpe went on to say that a project officer from BCC (John Mole) will now work with the TRA to ensure that the program is working and is meeting the agreed objectives throughout the life span of the project. Councillor Sharpe asked Raymond Goodwin to explain to the meeting what the projects aim was.

Raymond Goodwin from the Castle Vale tenants and residents alliance -Firstly Mr Goodwin said how pleased he was that this project was going to happen and that match funding from other organisations was already in place .He went on to say that "The Tyburn Pop up support service "would provide an outreach support service for the vulnerable residents within the Tyburn Ward (Pype Hayes, Erdington Hall, Birches Green and Castle Vale).The aim of the project is to provide services such as mobile library service ,finance advice services and health and employment service to the most vulnerable , by taking the service to them. Mr Goodwin said he would come to future the Ward meetings and update the Ward on how the project was progressing.

- 1. Virgin media Residents were concerned over the positioning of the cabinets on the foot paths. The main concern was the closeness to residents fencing which was making maintenance of the fences difficult .Councillor Clinton said there had been many such issues and concerns all over the City. She continued that the ward councillors had a long snagging list.
- 2. Wagtail Walk –Residents were concerned over the condition of Wagtail walk follow its disturbance after cabling work on the estate, they were particular concerned over not being consulted about the reinstatement.

The Councillors suggested to the assembled group that really this should be a topic for the next meeting and they proposed that an invitation should be extended to Virgin Media and the Engineers so that the Ward and its residents could discuss this matter. It was proposed that the next meeting should take place at Castle Vale TRA on the 23rd of February.
