1. Purpose of report:
<p>To consider a representation that has been made in respect of an application for a Premises Licence which seeks to permit the Sale of Alcohol (for consumption on the premises only) to operate from 4:00pm until 2:30am (Monday to Friday) and 11:00am until 2:30am (Saturday and Sunday).</p> <p>The provision of Regulated Entertainment consisting of live music and recorded music, to operate indoors only, from 4:00pm until 2:30am (Monday to Friday) and 11:00am until 2:30am (Saturday and Sunday).</p> <p>To permit the provision of Late Night Refreshment, to operate indoors only, from 11:00pm until 3:00am (Monday to Sunday).</p> <p>Premises to remain open to the public from 4:00pm until 3:00am (Monday to Friday) and 11:00am until 3:00am (Saturday and Sunday).</p>

Subject: Objection in relation to live music application - Jukeboxers Duelling Piano Bar, Arena Unit 1. B1 2AA

To the planning officer,

I would like to strongly object to the above proposal of a live music venue being given a license at this address.

I have enclosed a photograph of the proximity of my home to the venue.

I object on the grounds of public nuisance in relation to the licensing objectives. You may wonder why on earth I object to noise nuisance when I live next to the Birmingham Arena, well the truth is that on show nights, the noise is constant and not unwelcome and crowds are dispersed by 11pm. We can hear no music from inside. It is as quiet as the dead of night after 11pm. On non show nights, there is very limited footfall all around the arena making it an extremely peaceful place to live.

The bar which did occupy this unit, namely Bottega, was always very quiet in terms of customers but on the few occasions that they tried live music, we did experience a lot of noise nuisance. Firstly, the entrance is opposite my bedroom on the other side of the canal. There is only a single door, so no second inner door to block sound escaping when the door opens. The frontage is fully glass so no soundproofing can be made. There is no rear smoking area, so smokers gather effectively outside my window until late talking loudly and smoking.

Secondly, the sound of music from the venue will prevent me and my two children from sleeping. How will I know what time to expect the music to finish, how will I sleep, how will my children manage to cope at school when they are kept awake?

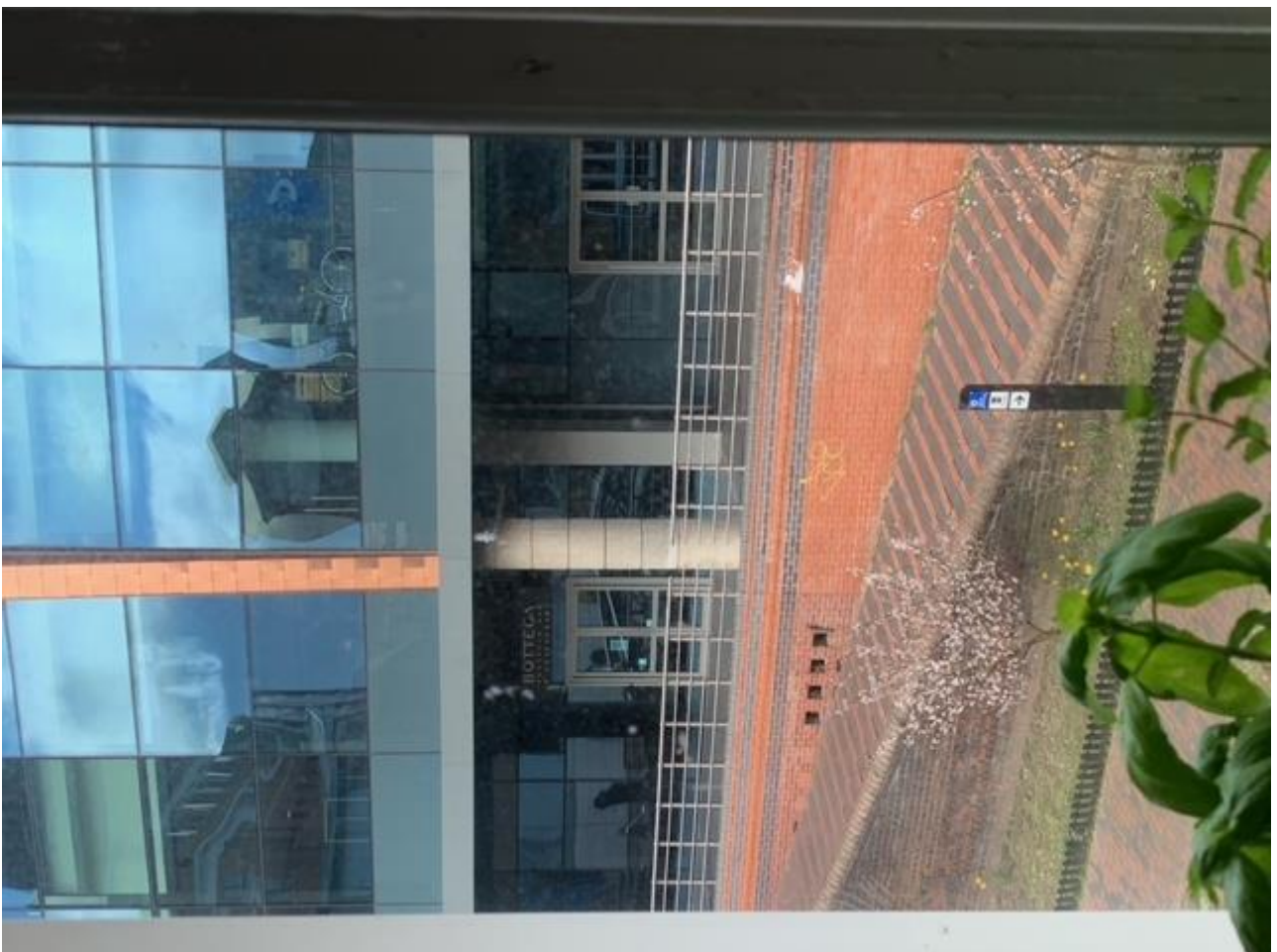
Thirdly, antisocial behaviour. The music license will allow all types of music to be played, if the owners find that the very civilized piano music isn't bringing in customers, there is no reason that they can't try for eg Rock, or House music. The security provided by Brindley Place doesn't cover this area, apart from the Westside wardens who are not a security company, so what if the popular nights draw in beggars and addicts (who are never far away from this area) so having security and other unwelcome guests? All of this adds up to a noise nuisance.

Describe the steps you intend to take to promote the four licensing objectives:

a) General – all four licensing objectives (b, c, d and e) (please read guidance note 10)

1 All staff shall be suitably trained for their job function for the premises. The training shall be written into a programme ongoing and under constant review and shall be made available to a relevant responsible authority when called upon.

b) The prevention of crime and disorder

2 A properly specified and fully operational CCTV recording system shall be installed, operated and maintained. The system shall incorporate a camera covering each of the entrance doors and be capable of providing an image which is regarded as 'identification standard' of all persons entering and/or leaving the premises. The CCTV system shall be in operation at the premises at all times when the premises are used for the provision of licensable activity. All CCTV recordings shall be securely stored for a minimum of thirty-one days. A staff member from the premises who can operate the CCTV system shall be on the premises at all times when the premises are open to the public. This staff member shall be able to show Police recent data or footage with the absolute minimum of delay when requested. Signage indicating that a CCTV recording system is in operation shall be displayed prominently in the premises.

3 The premises licence holder shall uphold a zero tolerance policy in relation to illegal drugs.

4 Any person entering the premises who appears to be under the influence of alcohol or illegal drugs shall in the interests of other members of the public using the premises be requested to leave the premises.

5 The external seating area shall be monitored frequently and shall be closed to diners at 22:00 each night.

6 A premises incident book shall be kept at the premises. This book shall be maintained and kept for a rolling period of 12 months. The incident book shall record all incidents which may have occurred which are relevant to the supply of alcohol and the promotion of the licensing objectives. Such incidents shall include, but not be limited to, complaints made to the premises alleging nuisance or anti-social behaviour by persons attending or leaving the premises and all refusals to sell alcohol. The incident book shall be readily available for inspection by an authorised person upon reasonable request.

7 All drinks promotions shall be risk-assessed to ensure the promotion is not irresponsible. Each risk-assessment shall consider the nature of the premises, the nature of the promotion including the size and duration of any discount and the type of customer potentially attracted by the promotion.

8 All door supervisors shall enter their full details in the premises daily register at the commencement of work. This shall record their full name, home address, contact telephone number, SIA registration number and the time they commenced and concluded working. If the door supervisor was supplied by an agency details of that agency shall also be recorded including the name of the agency, the registered business address and a contact telephone number.

9 Each event shall be risk-assessed by the premises licence holder further to the requirement for the use of door supervisors. Where it is assessed that door supervisors will aid the promotion of the licensing objectives SIA-registered operatives from a reputable company will be employed on a minimum ratio of one door supervisor to every fifty customers.

c) Public safety

10 All exit routes and public areas shall be kept unobstructed, shall have non-slippery and even surfaces, shall be free of trip hazards and shall be clearly signed.

11 No accumulation of combustible rubbish, dirt, surplus material or stored goods shall be permitted to remain in any part of the premises except in an appropriate place and of such quantities so as not to cause a nuisance, obstruction or other safety hazard.

12 Regular checks and maintenance shall be carried out on all equipment, electrical installations, emergency lighting and fire alarms and equipment to ensure their continued safe operation. A written record of these checks shall be kept and made available to an authorised officer of the licensing authority.

13 The premises licence holder shall ensure that a suitable fire risk assessment and emergency plan is in place at all times.

14 The premises licence holder shall ensure that an electrical compliance check is made at least once a year.

15 The edges of the treads of steps and stairways shall be conspicuously displayed.

d) The prevention of public nuisance

16 Signage requesting customers to be respectful of others when entering or leaving the premises shall be installed in a prominent position by the premises' exit.

17 An automatic door closer shall be installed at the premises' entrance to aid the prevention of noise leakage.

18 Entertainment shall be held internally only; no music or speakers shall be provided to external areas of the premises.

19 The premises' equipment shall be properly sound insulated and shall be operated strictly in accordance with the manufacturers' requirements, guidelines and tolerances.

20 The premises licence holder shall implement a written queue management policy. All queuing outside the premises shall be managed in such a way that prevents noisy or rowdy behaviour and therefore minimises disturbance or nuisance to neighbours.

21 The premises licence holder shall implement a written dispersal policy to move customers from the premises and the immediate vicinity in such a way as to cause minimum disturbance or nuisance to neighbours both residential and business and to make the minimum impact upon the neighbourhood in relation to potential nuisance, anti-social behaviour, crime and disorder.

22 Patrons smoking outside the premises shall be monitored regularly to ensure the potential for noise nuisance is controlled.

23 After close of business a rubbish patrol shall pick up any flyers or rubbish which has been left in the close vicinity of the premises by customers including any bottles which may have been taken off the premises.

24 No person shall be allowed to leave the premises whilst in the possession of any drinking vessel or open glass bottle, whether empty or containing any beverage unless moving from the restaurant to the external seating area.

e) The protection of children from harm

25 A Challenge 25 proof of age scheme shall be operated at the premises where the only acceptable forms of identification are the following recognised photographic identification cards: a driving licence, a passport, a military identification card or a Proof of Age card carrying a 'PASS' hologram.

26 A prominent clear notice shall be displayed at the point of entry to the premises advising customers that they may be asked to produce evidence of their age if seeking to purchase alcohol.

- the date and time of the incident
- a description of the person seeking to buy alcohol
- the name of the staff member who refused the sale
- the reason the sale was refused

28 All entries must be made within 24 hours of the refusal. The record must be made available for inspection when requested by an officer of a Responsible Authority.

29 All occasions when persons have been refused service shall be recorded in the incident book.

30 All children shall be accompanied by an adult whilst on the premises and must vacate the premises by 22:00.

- A birth or adoption certificate issued in the Channel Islands, the Isle of Man or Ireland **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A certificate of registration or naturalisation as a British citizen, **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A **current** passport endorsed to show that the holder is allowed to stay in the UK and is currently allowed to work and is not subject to a condition preventing the holder from doing work relating to the carrying on of a licensable activity.
- A **current** Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the holder which indicates that the named person can currently stay in the UK and is allowed to work relation to the carrying on of a licensable activity.

Home Office online right to work checking service

As an alternative to providing a copy of the documents listed above, applicants may demonstrate their right to work by allowing the licensing authority to carry out a check with the Home Office online right to work checking service.

To demonstrate their right to work via the Home Office online right to work checking service, applicants should include in this application their 9-digit share code (provided to them upon accessing the service at <https://www.gov.uk/prove-right-to-work>) which, along with the applicant's date of birth (provided within this application), will allow the licensing authority to carry out the check.
