Review application received on 15th November 2021 from the Chief Inspector of Weights & Measures in respect of Super Choice News, 939 Walsall Road, Great Barr, Birmingham, B42 1TN.

Good Morning Licensing,

West Midlands Police support the representation made by Birmingham Trading Standards, Naseem Shamas on behalf of the Chief Inspector of Weights & Measures regarding Super Choice News, 939 Walsall Road B42 1TN – premises licence number 3858.

The representation is supported under the protection of children from harm, public safety and prevention of crime & disorder licensing objectives.

The sale of alcohol to children appears to be an on-going problem at this premises.

The fact the member of staff behind the till didn't take any notice or challenge the child would indicate that selling alcohol to children is the norm in this premises.

It has been noted that Trading Standards had previously visited in May 21 after receiving intelligence that the premises had sold alcohol to two 15 year old girls.

On this occasion the premises was left a 'Traders Notice' by Trading Standards Officers who also spoke with Mr Sajjad (the premises licence holder and DPS) on the phone regarding the allegation, as he was not at the premises at the time of the visit.

Only 5 months after the first visit, Trading Standards carried a test purchase operation using a 15 year old girl volunteer.

The child was sold alcohol by the member of staff at the premises without question, not being asked for ID and in fact not even coming off the phone to serve her. Again as the previous visit by trading standards the DPS & PLH was not at the premises.

The sale of alcohol to children can only be monetary led and profit orientated. The possible consequences of such actions seemingly of no concern as long as money is 'going in the till.'

The effect of alcohol on children can be devastating and they are at increased risk of poor health, committing crime, being sexually exploited and poor educational results and missing periods of schooling. Drinking alcohol can affect a child's normal development of vital organs and their functions including the brain, liver, bones & hormones.

It is also noted that the premises have the following conditions imposed on their premises licence:

- *The premises should adopt a challenge 21 policy* – obviously this has not been the case.
- *All staff at the premises will be trained with regards to the licensing act 2003 and the sale of alcohol* – this has neither not happened or the training has been totally ineffective and inadequate.

West Midlands Police have no confidence in the management of these premises promoting the licensing objectives especially the protection of children from harm, prevention of crime & disorder and public safety, putting money and profit over their legal and moral responsibilities.

West Midlands Police agree with the recommendation of Trading Standards that the premises licence should be revoked.

On 24 May 2021 Trading Standards Enforcement Officer Paul ELLSON visited the premises of Super Choice News due to an anonymous complaint received that two 15-year-old girls had purchased alcohol from there. The licence holder was not present in the shop and the person who was behind the till appeared not to understand English. Officer ELLSON then spoke to Mohammad SAJJAD the licence holder on the phone whilst in the shop; he explained that a complaint had been received and explained the law on underage sales and reminded him that a refusal register must be maintained and that sales should be challenged. Officer ELLSON provided an advisory pack for tobacco and alcohol on age restricted products and left a trader notice no 14348 for the licence holder.

On 16 October 2021 Trading Standards carried out a test purchase operation and visited Super Choice News. A 15-year-old female volunteer took part in the test purchase of alcohol.

On 16 October 2021 at around 11.22 hours Officer Geary WARMINGTON carried out a risk assessment of Super Choice News 939 Walsall Road Birmingham B42 1TN. On entry he observed an Asian woman behind the till area who was on her mobile phone, he observed further that the woman was still on her phone when he left the premise.

At around 11.24 hours Officer Naseem SHAMAS went into the shop and was followed shortly after by the volunteer. Officer SHAMAS observed a lady was behind the till area on her mobile phone. The 15-year-old volunteer was sold a bottle of 4% alcohol WKD drink for £3.00 and then left the shop, followed by Officer SHAMAS. Officer SHAMAS observed the lady behind the till area was still on her mobile phone. The volunteer handed the alcohol bottle to Officer WARMINGTON the officers and volunteer returned to their vehicles. Officer WARMINGTON placed the bottle in an evidence bag.

Then Officer SHAMAS and Enforcement Officer y WARMINGTON went back into the shop at around 11.40 hours and spoke to the Asian woman who was behind the till area. Officer WARMINGTON advised the woman that alcohol had been sold to a person under the age of 18 and that it was an offence under The Licensing Act 2003 and that the facts would be reported. Officer SHAMAS asked the lady for the refusals register it appeared she did not know what it was; she stated her husband deals with the paperwork. The woman could not speak English fluently. The woman called the Premises Licence Holder and Officer WARMINGTON had a conversation advising that alcohol was sold to an underage person and a notice would be left for him and he must give a recording of the CCTV footage as outlined in the trader notice. The woman gave her name as Asma NAUSHEEN. Asma NAUSHEEN was given a trader notice No.14168 which she signed and was given a copy to hand to the Premises Licence Holder of the shop. The Officers left the premises at around 12.00 hours.

The sale of alcohol to persons under the age of 18 is a serious offence under The Licensing Act 2003. It also has serious consequences when it gets into the hands of young people as illustrated in the circumstances leading up to the test purchase operation. Not least it can make them vulnerable and likely to all kinds of unwanted actions and influences.

There is no excuse at all for making the sale to the volunteer; this was done by Asma NAUSHEEN who made the sale of the alcohol to an underage person she is the wife of licence holder and the DPS who is Mohammad SAJJAD.

Previous history of this shop.

The current licence for this premises was granted on 9 August 2012. The test purchase exercise was undertaken due to having received a complaint.

Recommendations.

The premises has been advised in the past and as a licence holder has no excuse to not adhere to the law and a sale to an underage person should not have taken place.

To leave someone in charge who doesn't understand the law doesn't demonstrate a well run business.

They have breached three of the licensing objectives and have little regard for the law.

I would ask that the Committee consider all outcomes at their disposal but due to the seriousness of the matters would recommend that the best course of action is for the licence to be revoked to prevent further harm to the neighbourhood.

Dear Sirs/Madams,

Ref. To hearing at the Licensing Sub Committee C at 10.00am on Wednesday 12 January 2022.

I do not wish to participate nor be represented at the hearing. This is because I feel it is not necessary, as I will list reasons below in my defense.

My statement as follows:

1. I wish to totally refute that this has been an ongoing problem at the premises.
2. Regarding the incident in May 2021, I was at the time visiting Pakistan due to family problems. Due to Covid, I got stuck in the country for much longer than planned and had intended. I had left an additional member of staff and my wife to run the store. It is my opinion, that although I have given them both adequate training and warnings, that these unfortunately were not followed through.
3. On the second time or the latest occasion, my wife was on the phone because her aunt had just passed away in Pakistan and she was in a very distressed state. The customer to whom the alcohol was sold was masked due to the covid protection and was well built and tall and thus appeared to be an adult. It was because of this that this very serious mistake was made. We both apologise profusely for these two incidents.
4. I have since this incident, updated the training of my wife Asma Nosheen Sajjad, to ensure that nothing like this will ever occur again.
5. I humbly request that my licence is not revoked, as it is the main means of my livelihood. I cannot make enough money from the other items sold on the premises to meet the very high overhead costs. I will therefore be forced into bankruptcy and close down.

Also, If I were to try and sell the business, it will be very unlikely that I could sell it without the permission to sell Alcohol. This is because of the location of the premises and the very high overhead costs attached, as I have been advised by estate agents.

No supply of alcohol may be made under the premises licence (a) at a time when there is no designated premises supervisor in respect of the premises licence, or (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

Every retail sale or supply of alcohol made under this licence must be made or authorised by a person who holds a personal licence.

The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol:- The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.

Annex 2 – Conditions consistent with operating schedule

2a) General conditions consistent with the operating schedule

All staff at the Premises will be trained with regards to the Licensing Act 2003 and the sale of alcohol. A record of the training shall be maintained at the Premises.

The Premises Licence holder will install CCTV to be fitted to the specifications and recommendations of West midlands Police Licensing dept at Birmingham Central Police Station).

I am employed by West Midlands Police as a Licensing Officer currently based as Lloyd House, Colmore Circus Birmingham B4 6NQ working within the Central Licensing Team. This team has responsibility for all licenced premises within the Birmingham City Council area.

I am making this statement in relation to West Midlands Police supporting representation to Trading Standards review applicant of the premises licence 3858, Super Choice News, 939 Walsall Road, Great Barr B42 1TN.

The review was submitted by Trading Standards after they carried out a test purchase operation whereby a 15 year child was able to purchase alcohol from the premises on 16th October 2021.

The child was able to purchase a bottle of WKD without question from the member of staff behind the till; in fact the staff member seemed so uninterested in the purchase she remained on her mobile phone throughout.

Once the 15 year old child volunteer had left the premises Trading Standards Officers approached the member of staff and informed her that they had just witnessed her sell alcohol to a person under the age of 18.

The officers asked the member of staff for the premises refusals book, she stated that she didn't know where it was and that her husband dealt with all the paperwork.

The member of staff then phoned the DPS (who is also the premises licence holder) and Trading Standards officers spoke with him.

Previous to this test purchase fail, Trading Standards had received a complaint that two 15 year old girls had been able to purchase alcohol from this shop.

Officers from Trading Standards then visited the premises on 24th May 2021, after the complaint. On this occasion the DPS and premises licence holder was not present and again a sole member of staff was left in charge of the premises. Officers again spoke with the DPS on the phone and advised him of the complaint, explained the law around underage sales and also reminded him that a refusals register should be kept.

West Midlands Police note that there are only around 5 months between the initial Trading Standards visit in May to the failed test purchase in October.

It is also noted that the advice given by Trading Standards in May has seemingly been totally ignored by the premises licence holder with striking similarities between the compliant received, the advisory visit and the failed test purchase.

The age of the children that were sold alcohol is 15.

The DPS and premises licence holder is not on site.

There is a sole member of staff left in charge of the premises.

The lack of a refusals book or knowledge of such book.

The premises have a number of conditions attached to their licence which include:

All staff at the premises will be trained with regards to the licensing act 2003 and the sale of alcohol.

The premises shall adopt a challenge 21 policy.

These conditions have been imposed onto the premises licence to protect children and the vulnerable.

Obviously the premises have breached the challenge 21 policy as a 15 year old child was able to purchase alcohol without question.

The other condition of staff training regarding the licensing act has either not happened or has been totally ineffective and inadequate. The member of staff could not even find the refusals register or even appeared to understand what it was, stating that her husband dealt with the paperwork.

The effects of alcohol can be devastating on children, with the NHS on line stating that alcohol use during the teenage years is related to a wide range of health and social problems, including;

Drinking alcohol can damage a child's health, even if they're 15 or older. It can affect the normal development of vital organs and functions, including the brain, liver, bones and hormones.

Beginning to drink before age 14 is associated with increased health risks, including alcohol-related injuries, involvement in violence, and suicidal thoughts and attempts.

Drinking at an early age is also associated with risky behaviour, such as violence, having more sexual partners, pregnancy, using drugs, employment problems and drink driving.

Barnardo's state on line that young people who use alcohol are increased risk of:

- Missing school
- Poor health
- Committing crime
- Being sexually exploited

The sale of alcohol to children can only be financially led and profit orientated. The possible consequence of such acts seemingly of no concern to the premises licence holder, as long as there is money going in the till.

The sale of alcohol to children would appear the norm at these premises as the member of staff who sold the bottle of WKD to the child didn't even bother to come off the phone and challenge a 15 year old girl.

This child was a volunteer for Trading Standards, who would have looked her age and would not have been attempting to look old enough to legally purchase alcohol.

West Midlands Police have no confidence in the management of these premises to promote the licensing objectives, especially the protection of children from harm, prevention of crime & disorder and public safety.

The premises had received an advisory visit from Trading Standards only 5 months prior to this underage sale, again for the sale of alcohol to children which indicates that selling alcohol to children is an on-going issue at the premises.

This strengthens West Midlands Police stance of having no confidence in the management of this premises and in their ability or desire to promote the licensing objectives.

The management have put money and profit over their legal, moral and social responsibilities.

West Midlands Police would agree with Trading Standards recommendation that this premises licence should be revoked.
