1. Welcome & Notice of Recording

2. Section 114 Notice

The council has declared a Section 114 notice, which means a Birmingham City Council has judged itself to be in financial distress and can no longer balance its budget. 3. Bournville Village Trust (BVT)

Elaine Li from BVT introduced herself as the Community Development & Involvement Manager from BVT.

- BVT operate in local church groups and meet once every 6 weeks
- Warm spaces were not as successful as anticipated last Winter and hope the interest in this years Warm Spaces are more successful
- Income recovery team Will be creating a new resource local to the ward. Will include various activities, job's fairs, advice surgeries
- DWP Selly Oak are holding a job's fair on Tuesday 17th October 2023 at Shenley Court Hall, 200 Green Meadow Road, Selly Oak, B-ham, B29 4ED

4. Bournville Place for People (BPP)

A consultation was put in to redesign of a number of roads to create safer calmer streets, reduce congestion and pollution and to increase the cycling infrastructure.
