Summary and evidence of findings from your EIA

In accordance with legislative requirements during 2016 the five yearly Electricity at Work Act testing was undertaken to the Council House Complex. The outcome of this test, together with previous technical reports, confirmed the poor condition of the electrical installation.

A review was undertaken to assess the condition and life expectancy of the services infrastructure, particularly electrical and mechanical installations, across both the Council House and the Extension.

The report concluded that the electrical installations are in an unsatisfactory condition and recommended replacement in the near future with a more frequent testing regime in the interim if works for any reason were not undertaken; this is one of the key drivers for the proposals to undertake the works. As a result of the test a number of remedial works were required to isolate existing cabling and replace with temporary supplies (cost of c£52k).

There has been ongoing consultation with Members of their respective constituency, who have as representation been consulted on issues of relevance.

There have been no issues raised which impact the wider community negatively, therefore a Full Equality Assessment is not required at this design stage.
