**Dear Licensing** 

## Please find below AMENDED submission that supersedes my previous comments and should be used.

I am writing to oppose granting an extended license for this premises and sale of alcohol. It will be a serious error and cause misery for residents on Monument Road and in the vicinity.

The premises is currently operating as a Shisha Lounge – and I have had numerous complaints from residents with regards to its existing operating hours. Obtaining a license until 1am in the morning Sunday to Monday will cause untold misery for residents, and a license until 3am on Friday to Saturday will only compound existing issues. The extended service of alcohol on a premises with which residents already have existing issues will only exacerbate problems.

The area is well known for its issues around noise and antisocial behaviour and I have concerns approving this license will only serve to enhance these negative characteristics.

The existing business, in my opinion, has been burden on residents due to late night noise pollution, alleged antisocial behaviour, and dreadful illegal parking blocking this main access route. I have previously driven down this route on evenings of operation after 10pm and found absolute gridlock of traffic that is more familiar to a 5pm rush hour — all due to new businesses attracting nuisance parking.

I would also remark that having written to Jungle Shisha on a previous occasion to relay concerns from residents I believe I have never received a response. I would argue this does not portray a license holder that would seek to engage with the community or representatives.

I would ask that the licensing committee also liaise with the police regarding reports in this area linked to commercial premises and consider if we want to add to the problems of residents. Extending hours and allowing extended alcohol service would undermine of the chief purposes of licensing – to prevent nuisance, and I hope members will reflect on that before their decision.

Licensing will be aware I have previously raised concerns with regards to businesses operating on Monument Road.

Jungle Shisha Lounge 215-218 Monument Rd. B16 8UU Ladywood Ward Application to vary hours for entertainments, late night refreshments and sale of alcohol From Cllr Kath Hartley and Cllr. Albert Bore, Ladywood Ward

We object to any extension of the hours of operation of this venue because of the impact that it already has with its current licensed arrangements and of how any increase in the activities there would impact on local people and passers-by:

- Vehicles parked on-street on double yellow lines on both sides of Monument Rd. by customers are creating road safety dangers at the traffic lights at the Hagley Rd. junction and down to Plough and Harrow Rd. This also impacts on the Chamberlain Gardens Controlled Parking Zone arrangements outside older, Georgian residential properties on the Ladywood Ward side on the east of Monument Rd. Any extension of the hours will doubtlessly cause more issues. Ladywood residents have been complaining about this since the venue opened. Indeed, so have motorists from beyond the area.
- Monument Rd. has become even busier since the Metro works to Fiveways- when the road became
  an official alternative route to the Middleway- and the Clean Air Zone where we can see that noncompliant vehicles are being parked in streets off west side of Monument Rd. Air pollution has
  increased because of the increase in traffic. Additional use by the venue's customers can only
  exacerbate this.
- There are already 25 flats at the Edgbaston Student Studios- 197-199 Monument Rd. There is a recently-withdrawn planning application for a 3-storey rear extension for an *additional 8 self-contained flats* at 213-216 Monument Rd. (over and above the flats above shop units already in place). This should give you a clear impression of the increasingly-residential nature of this once-commercial road-most of it of Grade 11 Listed status. There should be no extension to the operating hours of any venue in this narrow, congested, mainly residential road.
- Another issue is that Monument Rd. has periodically been a hot spot for street prostitution and the
  other issues that arise from it. This also makes the extension of operating hours for the venue
  unwise.

Please add our objections to those of our colleagues in North Edgbaston Ward.






No supply of alcohol may be made under the premises licence (a) at a time when there is no designated premises supervisor in respect of the premises licence, or (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

Every retail sale or supply of alcohol made under this licence must be made or authorised by a person who holds a personal licence.

The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises. In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises -(a)games or other activities which require or encourage, or are designed to require or encourage, individuals to -(i)drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or(ii)drink as much alcohol as possible (whether within a time limit or otherwise)(b)provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective; (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective; (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner; (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).

(a)where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures -(i) beer or cider: 1/2 pint;(ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and(iii) still wine in a glass: 125 ml;(b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and(c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

(1) A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.(2) In this condition:-(a) 'permitted price' is the price found by applying the formula  $P = D + (D \times V)$ , where -(i) P is the permitted price,(ii) P is the amount of duty chargeable in relation to the alcohol as if the duty charged on the date of the sale or supply of the alcohol, and(iii) P is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;(b) 'duty' is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;(c) 'relevant person' means, in relation to premises in respect of which there is in force a premises licence -(i)

the holder of the premises licence,(ii) the designated premises supervisor (if any) in respect of such a licence, or(iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;(d) 'relevant person' means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and(e) 'value added tax' means value added tax charged in accordance with the Value Added Tax Act 1994.(3) Where the permitted price would not be a whole number of pennies, the permitted price shall be taken to be the price rounded up to the nearest penny.(4) Where the permitted price on a day ('the first day') would be different from the permitted price on the next day ('the second day') as a result of a change to the rate of duty or value added tax, the permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

An incident log will be maintained at the premises. Each entry will be signed off by the DPS. The log will be made immediately available to members of the responsible authorities on request.

CCTV that is approved by West Midlands police will be fitted in the premises. Images will be retained for a period of at least 31 days and will be made available to any of the responsible authorities to view or copies produced on request. If for any reason the CCTV hard drive needs to be replaced the previous / old hard drive will be kept on site for a minimum of 31 days and made immediately available to any of the responsible authorities on request. The CCTV will be checked to ensure that it is working each day prior to licensable activity taking place. The time of the check, the identity of the person carrying this out and the result of it will be recorded in the incident log.

All windows to be closed and remain closed while regulated entertainment is taking place after 2000 hours except for ingress and egress or cases of emergency.

While regulated entertainment is taking place the premises will ensure that regular noise assessments (minimum of 1 check every 3 hours) are carried out at the nearest residential property to ensure noise or vibration from the premises does not cause a public nuisance. These checks are to be documented, dated, timed and signed by the person who has made the check. This documentation to be made immediately available to any of the responsible authorities on request and held on the premises for a minimum of 3 months.

The volume of all entertainment/music will be controlled by the DPS, premises licence holder or their nominated representative and not the DJ.

The venue will not be hired out to third parties.

The premises will deploy door staff when trading as informed by the risk assessment. Door staff will sign on and off duty. The premises will keep a profile of all door staff which will include a copy of their SIA licence and photographic ID. (If photographic ID is not available then a utility bill no older than 3 months will be acceptable.) The signing in & out sheets and profiles will be kept on the premises for a minimum of 3 months and made immediately available to any of the responsible authorities on request. Door staff will wear a fluorescent coat, jacket or waistcoat while on duty at the premises. Door staff will remain on duty until all the customers have dispersed and this will form part of the premises dispersal plan.

The numbers of door staff will be risk assessed by the premises. This risk assessment will be made available to any of the responsible authorities immediately on request.

No persons under the age of 18 will be allowed into the premises unless accompanied by a person over the age of 18.

No persons under the age of 18 will be allowed to be on the premises after 23:00 hours.

Hot coal shisha will only be consumed in the outdoor area of the premises and the roof will be in the fully open position.

A fire alarm system will be installed to meet BS 5839 Part 1 current standards An emergency lighting system will be installed to meet BS 5266 current standards Firefighting equipment will be available in the premises to meet BS 5306 current standards Floor staff will conduct physical sweep inside the premises to remove hazardous objects/waste as deemed necessary by the management. The Designated Premises Supervisor is aware of his responsibilities to the staff and customers in respect of public safety and will take all reasonable steps to ensure the maintenance of all provided safety arrangements and equipment in accordance with the requirements of current installations.

Notices will be displayed at the exit of the premises asking patrons to leave the premises quietly. All deliveries will be conducted prior to 7pm to control noise nuisance. In conjunctions with the steps proposed for the prevention of crime and disorder objectives, the Licensees and staff will at all times remain responsible for the prevention of public nuisance in and around the premises. The Designated Premises Supervisor will arrange to monitor levels of noise from both inside and outside the premises and remedial action will be taken as appropriate. Doors and windows will be kept closed as deemed necessary by the Designated Premises Supervisor.

The Designated Premises Supervisor and staff will at all times remain aware of their responsibilities under the objective, including that alcohol shall not be sold to anyone under the age of 18. Staff on duty have will be trained and made aware of these requirements and the need to demand an acceptable form of age id. The premises will operate Challenge 25 policy. No adult entertainment is permitted at these premises.







#### 1. Purpose of report:

Officers have delegated authority to grant Permits in respect of up to 4 Licensed Premises Gaming Machines, Category C & D in an Alcohol Licensed Premises.

This application seeks to have permission to operate a total of 5 Category C Gaming Machines, at the premises.

#### 2. Recommendation:

The Sub-Committee is requested to consider the application to operate a total of 5 Category C Gaming Machines on an Alcohol Licensed premises.

#### 3. Brief Summary of Report:

An application for the variation of a Licensed Premises Gaming Machine Permit was received on 29<sup>th</sup> March 2023.

#### 4. Compliance Issues:

#### 4.1 Consistency with relevant Council Policies, Plans or Strategies:

The report complies with the City Council's Statement of Licensing Principles and the Council's Corporate Plan to improve the standard of all licensed persons, premises and vehicles in the City.

#### 5. Relevant background/chronology of key events:

JD Wetherspoon Plc submitted an application for the variation of a Licensed Premises Gaming Machine Permit on 29<sup>th</sup> March 2023 for the Elizabeth of York, 12A St Mary's Row, Moseley, Birmingham, B13 8JG.

The application, including supporting documents, is attached at Appendix 1.

Birmingham City Council Licensing Enforcement visited the premises and confirmed that they have no objections to the application. Their confirmation is attached at Appendix 2.

The premises have the benefit of a current Gaming Machine Permit issued under the Gambling Act 2005, which permits 4 Category C machines. See attached Appendix 3.

Gaming Machine Categories by maximum stake and maximum prizes available, see attached Appendix 4.

Site Location Plans at Appendix 5.

- 1. This form is to be used for the NOTIFICATION of up to 2 gaming machines of categories C and / or D under Section 282 of the Gambling Act 2005, or the GRANT / VARIATION / TRANSFER of a gaming machine permit under Section 283 and Schedule 13 of the Gambling Act 2005.
- 2. All references to 'Premises Licence' refer to a Premises Licence under the Licensing Act 2003 authorising the sale of alcohol for consumption on the premises.
- 3. The premises must be licensed under the Licensing Act 2003 to sell alcohol for consumption on the premises.
- 4. A 'Premises Licence holder' is a person holding a Premises Licence under the Licensing Act 2003.



#### Policy and Procedure Overview

We understand when considering this application that the Licensing Authority will consider the 3 objectives of the Gambling Act 2005 and therefore have set out below the policies and procedures JD Wetherspoon undertakes in its pubs to promote these objectives. In addition, the Gambling Commission's "Gaming Machine Permits Code of Practice" is complied with.

#### Protecting children and other vulnerable people from being harmed or exploited by gambling.

To ensure that no persons under the age of 18 are permitted to play on our gaming machines, we abide by a Challenge 21/25 policy in all of our premises. Under this policy, all of our employees are trained to ask any customer who appears to be under the age of 21/25 years to provide valid proof of age that they are over the age of 18. When in use, Door Supervisors are also fully briefed on our policy and what is expected of them in the implementation of the same.

JD Wetherspoon has adopted the industry standards and the recommendations of the Gambling Commission and recognises only the following forms of identification as valid forms of proof of age:

- Valid National passport (any nationality)
- Valid Photographic Drivers' Licence
- · United Kingdom 'PASS' accredited age identification card with photograph.
- UK Military ID
- Valid photographic European ID
- Ireland Age Card (Republic of Ireland only)
- NI Electoral Identity Card (Northern Ireland only)

We apply this policy to all age restricted activities on our premises.

All employees receive induction training on our Challenge 21/25 policy when they commence employment with the Company and then receive regular refresher training. All employees complete video training, quizzes and sign a letter to confirm that they have had this training and understand their responsibilities. Records of all training is retained centrally at head office via our online training platform. Staff training records are regularly reviewed by the pub management team and members of our Retail Audit department to ensure that the training system is being satisfactorily completed.

Staff compliance with our Challenge 21/25 policy is tested by a number of means:

- Management review of a 'refusals log' which records when and how often bar staff are recording when a sale has been refused.
- Independent mystery visitors who are aged 18 and 19 years are sent into our pubs to test compliance with our Challenge 21/25 policy.

Our Challenge 21/25 policy is also actively promoted within the premises using selfadhesive signs at every entrance and on/around gaming machines.

All front of house staff are aware of their responsibility for preventing underage gambling.

All machines are situated in a place where their use can be supervised and in front of the bar where possible to increase visibility.

Information shall be made available to customers on how to gamble responsibly and how to access information about and find help in respect of problem gambling. The Gamcare Charity's details are made available by way of a sticker on each of the gaming machines.

JD Wetherspoon ensures that there is always a duty manager working on every shift. This means that there is always a senior member of the team on duty to assist with the monitoring and supervision of persons using the machines should customer interaction be required.

## 2. Preventing gambling from being a source of crime or disorder, being associated with crime or disorder, or being used to support crime.

The power to all gaming machines is turned off after the pub has closed to ensure potential thieves are not attracted by the lights in the pub.

JD Wetherspoon pubs also have two types of alarm systems, the panic alarm and intruder alarm, which cover the majority of the pub including the customer area where gaming machines are located.

The monitored intruder alarm covers the main entry points when the pub is closed. It is mainly activated by a forced entry into the pub triggering the door contacts or motion detectors. This pub is internally described as having a 'level 1 response' to its alarm system, meaning police response. This is an automated system which feeds through to Secom central station, our alarm consultants, who notify the police and the registered key holders of the pub.

JD Wetherspoon prides itself on provide safe, well run premises for all people to enjoy themselves in. Over our estate of over 800 pubs we spend considerable time and resources ensuring they are all well equipped with adequate and appropriate CCTV coverage.

#### 3. Ensuring that gambling is conducted in a fair and open way.

All of our AWP machines are located in well supervised areas and are regularly monitored by staff and door staff.






