Consequently, the Council fears that the government will be unable to guarantee the best possible provision for our veterans community if austerity continues to result in significant cuts to frontline services."

After para 3 insert:

"The Labour Party has set out a new social contract for veterans, which would guarantee better access to mental health services, housing and education and training opportunities.

The social contract for veterans includes:

- Ending the scourge of veterans sleeping rough on our streets with homes reserved for people with a history of rough sleeping
- Free education and training through the National Education Service
- New career opportunities through increased apprenticeship numbers
- Mental health issues, like PTSD, treated as seriously as physical health issues.
