## 1. Purpose of report:

To consider representations that have been made in respect of an application for a Premises Licence which seeks to permit the provision of late night refreshment, to operate outdoors only, from 11:00pm until 03:00am (Monday to Sunday).

The provision of Regulated Entertainment consisting of recorded music, to operate indoors only, from 12:00midday until 02:00am (Monday to Sunday).

Premises to remain open to the public from 12:00midday until 03:00am (Monday to Sunday).

## 3. Brief Summary of Report:

An application for a Premises Licence was received on 29<sup>th</sup> December 2021 in respect of Burger and Sauce, 38 – 44 High Street, Kings Heath, Birmingham, B14 7LB.

I would wish to object to BSKH's application to be open for late night refreshments until 3am. Since opening this venue has already seen a number of incidents and has become a draw for significant gatherings of young people from different parts of the community who are hostile to each other. In a recent incident concerns were raised with the management of the premises who said they could not get involved in dealing with disturbances directly outside their venue or between different customers as that could be bad for business and invite repercussions. A view that is understandable but is a form of management that is utterly inappropriate to the late night opening of a venue that could easily become a food and fight magnet for people leaving late night pub openings. Residents from Grange road have made various representations to me and are also concerned about the noise nuisance and risk of ASB occurring on the residential areas that abut the premises. I would ask that this licence is refused on the basis of the prevention of crime and disorder, the protection of public safety and the prevention of nuisance.

I wish to object to the granting of this licence. I am a resident of Grange Road (address below).

I objected to the Planning Application for this fast food outlet.

Since the outlet has opened, pretty much all of my original objections have come to pass:

Traffic has increased - the High Street end of Grange Road is permanently knotted with cars entering and leaving and turning round - it is now routine behaviour for customers to park on the double yellow lines at the entry to Grange Road - right now at time of writing there are two cars on the north side of the road and three on the south (both sides are double yellow) - sometimes people are actually double-parked here, with other cars parked on the footpaths - on two occasions we have arrived home in the evening to find it impossible to drive our car into Grange Road because it is blocked by cars illegally parked.

Antisocial behaviour has increased - many of those who illegally park sit in their cars eating their food and then drop all their litter out of their windows - we hear loud altercations at night - swearing and shouting - I have witnessed a fist fight between two adult males at night.

Litter has increased - litter is now everywhere, and it is pretty much all from Burger & Sauce - last week I walked down Grange Road early in the morning to see that a rat had been run over by a car while it was eating a clearly branded Burger & Sauce wrapper, and a crow was in the process of eating the rat's brains - seriously...

Please do not grant this licence. In fact - instead of granting a licence to allow the owner to sell alcohol, play music til 2am, and stay open til 3am every day - please do Grange Road and Kings Heath a massive favour and shut them down.

I wish to oppose the application from Burger and Sauce ,King's Heath B14 7LB to open to 3:00am everyday and to play recorded music to 2:00am.


As you are aware Burger and Sauce is on the corner of a residential street, granting this application will have a detrimental effect on the quality of life for residents on Grange Road for reasons listed below .

- 1) Playing music up until 2 am 7 days a week will result in reduced sleep for residents who live close by (There are houses less than 50yds from the premises).
- 2) Several residents have young children who will have their sleep disturbed which will in turn affect concentration and ability to learn in school.
- 3)Increased footfall and cars driving down the road in the middle of the night will also affect the quality of sleep for residents.
- 4) Opening so late will also serve to make the corner of the road significantly more dangerous. Since the opening of the restaurant cars tend to park on the corner of the road(where there are yellow lines which makes it difficult for drivers turning onto Grange Road.) They are also parked on pavements making the pavements unsafe for pedestrians.

Furthermore this application has been made with no consideration for residents directly affected by the plans we have not been consulted and were only made aware as a resident saw the notice of application in the shop window.

Dear licensing team

I am contacting you regarding a licensing application for burger and sauce kings heath to play recorded music until 02.00 Monday-Sunday and to extend its opening times until 03.00 Monday-Sunday. I strongly disagree with this proposal for the following reasons:

- 1. The part of Grange Road in which burger and sauce is based is very much a residential street with houses at the back, opposite of the unit and above neighbouring shops. Playing music will cause disruption to sleep for both adults and, more importantly, children. Because of the walls of surrounding buildings, sounds are reflected and are loud we have had this issue with extractor fans in the past.
- 2. Customers leaving at 3am are unlikely to be quiet. Again, this is likely to cause issues with people sleeping. I fail to see the need to open until 3am, particularly on a week night.
- 3. There have already been issues with anti social parking on double yellow lines and on pavements around the restaurant. This often results in horns being sounded late at night. People also sit with their cars running and engine sounds are audible. Opening later will make this an issue at a later time when we are trying to sleep.
- 4. There is not a precedent for this late opening for other local business on week days:
- Hi Tide closes at 11:30pm
- King Kebab closes at 1:30am
- Pepe's Piri Piri closes at 2:00am
- Dixy Chicken is closes at midnight.

Opening until 03:00 and playing music until 02:00 is extreme, and Burger and Sauce is closer than the above restaurants to residential homes.

For the reasons above I would like to reiterate that I am strongly opposed to this, as are many of my neighbours who I hope have also emailed you.

Around the restaunt is a highly populated residential area, and many families live here with children. We all have a right to sleep so we can go to work and attend school refreshed. Music until 2am and opening until 3am is unnecessary and will be highly disruptive.

I am making a representation regarding the application for Premises Licence by BSKH Ltd at Burger and Sauce, 38-44 High Street. As a local Kings Heath resident I ask that this application be rejected by the council, for three reasons:

- the location of the Burger and Sauce restaurant subject to the application is on the corner of a residential street (Grange Road) and the granting of extended opening hours until 3am, the right to play recorded music until 2am and serve food until 3am will cause evening and night-time disruption to residents. It is not appropriate for a venue so close to private residences to have such late opening hours.
- the current restaurant has, since opening, led to an increase in illegal and unsafe parking behaviour on Grange Road, including vehicles parking across the pavements. Since 'Burger & Sauce' opened the High Street and Grange Road have suffered from:



Dear Sir / Madam

As the owner of Grange Road, I write to object to the proposed increase in opening hours and right to play recorded music till 2 am at Burger and Sauce in Kings Heath (B14 7LB). The venue has caused a great deal of disruption to the area already. Numerous complaints have been made about anti-social behaviour, including littering, loitering, noise pollution and obstructing the pavements. Although the area immediately outside the venue is supposed to be a double yellow line area, it is frequently blocked with cars, which park on the pavements and completely close the road at busy periods. Parking on Grange Road has become a constant problem for residents since the introduction of the LTN, and this venue has exacerbated the issue. The owners of these cars do not eat inside the venue but instead sit in their cars playing loud music and blocking the pavements; they then throw their burger wrappings onto the pavements.

Kings Heath high street currently plays host to a number of late-night fast food venues; however, due to the placement of this one on the corner of a residential street, which has a nursery on it, it has hugely increased traffic, parking problems, litter on a road that already suffered from these problems. As a new parent with a 4-month-old baby, we have frequently been unable to park the car anywhere near our house or get the pushchair past the cars which are parked on the pavements or, if they are parked on the road (still on double yellow lines), block the drop curbs we use to cross the road. When there is little to no police or traffic warden on the road, the increased late-night traffic is wholly unacceptable. Furthermore, why does a fast-food restaurant catering to a largely takeaway clientele need to play loud recorded music until 3 am? This proposal is not in keeping with the neighbourhood, nor does it align with the aims of the Low Traffic Neighborhood; all it will do is increase traffic and litter on an already crowded street.

As a resident at Grange Road, Kings Heath, Birmingham B14 I am making a representation to object to extended opening hours at the premises above. I am especially concerned about recorded music late at night until 2am on 7 nights a week. I live very close to these premises. There are already an excessive number of food venues in Kings Heath and there is absolutely no need for this one to extend opening hours until 3am every night.

#### **Details of my representation**

- a) Prevention of crime and disorder this is a residential area and the proposed extension of opening hours including the playing of recorded music will cause noise nuisance, attract customers late at night and create more litter. This is entirely unreasonable when these premises were previously occupied by Argos (useful to residents) which closed at a reasonable time in the early evening.
- b) Protection of public safety as a widow living alone I have no desire for late night noise and disruption which make it difficult to sleep. My bedroom is at the front of the house and it is already difficult to sleep when noisy customers are leaving nearby premises. Alcohol only worsens loud arguments late at night.
- c) Prevention of public nuisance late night opening will encourage extra customers to the area at a time when residents are sleeping. Grange Road is part of the Low Traffic Neighbourhood and attracting more traffic to the area late at night where parking is already difficult conflicts with the desire to make this a more peaceful and welcoming area for residents.
- d) Protection of children from harm young children living opposite me are also entitled to a peaceful night's sleep and a litter-free environment.

Entitlement to work/immigration status for individual applicants and applications from partnerships which are not limited liability partnerships:

A licence may not be held by an individual or an individual in a partnership who is resident in the UK who:

- does not have the right to live and work in the UK; or
- is subject to a condition preventing him or her from doing work relating to the carrying on of a licensable activity.

Any premises licence issued in respect of an application made on or after 6 April 2017 will become invalid if the holder ceases to be entitled to work in the UK.

Applicants must demonstrate that they have an entitlement to work in the UK and are not subject to a condition preventing them from doing work relating to the carrying on of a licensable activity. They do this in one of two ways: 1) by providing with this application copies or scanned copies of the documents listed below (which do not need to be certified), or 2) by providing their 'share code' to enable the licensing authority to carry out a check using the Home Office online right to work checking service (see below).

#### Documents which demonstrate entitlement to work in the UK

- An expired or current passport showing the holder, or a person named in the passport as the child of the
  holder, is A British citizen or a citizen of the UK and Colonies having the right of abode in the UK [please see

- A Registration Certificate or document certifying permanent residence issued by the Home Office to a national

- A Permanent Residence Card issued by the Home Office to the family member of a national of a European Economic Area country or Switzerland.
- A current Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the
  holder indicating that the person named is allowed to stay indefinitely in the UK, or has no time limit on their
  stay in the UK.
- A current passport endorsed to show that the holder is exempt from immigration control, is allowed to stay
  indefinitely in the UK, has the right of abode in the UK, or has no time limit on their stay in the UK.
- A current Immigration Status Document issued by the Home Office to the holder with an endorsement
  indicating that the named person is allowed to stay indefinitely in the UK or has no time limit on their stay in
  the UK, when produced in combination with an official document giving the person's permanent National
  Insurance number and their name issued by a Government agency or a previous employer.
- A birth or adoption certificate issued in the UK, when produced in combination with an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A birth or adoption certificate issued in the Channel Islands, the Isle of Man or Ireland when produced in
  combination with an official document giving the person's permanent National Insurance number and their
  name issued by a Government agency or a previous employer.
- A certificate of registration or naturalisation as a British citizen, when produced in combination with an
  official document giving the person's permanent National Insurance number and their name issued by a
  Government agency or a previous employer.

- A current passport endorsed to show that the holder is allowed to stay in the UK and is currently allowed to
  work and is not subject to a condition preventing the holder from doing work relating to the carrying on of a
  licensable activity.
- A current Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the holder which indicates that the named person can currently stay in the UK and is allowed to work relation to the carrying on of a licensable activity.
- A current Residence Card issued by the Home Office to a person who is not a national of a European Economic
  Area state or Switzerland but who is a family member of such a national or who has derivative rights or
  residence.
- A current Immigration Status Document containing a photograph issued by the Home Office to the holder
  with an endorsement indicating that the named person may stay in the UK, and is allowed to work and is not
  subject to a condition preventing the holder from doing work relating to the carrying on of a licensable activity
  when produced in combination with an official document giving the person's permanent National Insurance
  number and their name issued by a Government agency or a previous employer.
- A Certificate of Application, less than 6 months old, issued by the Home Office under regulation 18(3) or 20(2)
  of the Immigration (European Economic Area) Regulations 2016, to a person who is not a national of a
  European Economic Area state or Switzerland but who is a family member of such a national or who has
  derivative rights of residence.
- Reasonable evidence that the person has an outstanding application to vary their permission to be in the UK
  with the Home Office such as the Home Office acknowledgement letter or proof of postage evidence, or
  reasonable evidence that the person has an appeal or administrative review pending on an immigration
  decision, such as an appeal or administrative review reference number.
- Reasonable evidence that a person who is not a national of a European Economic Area state or Switzerland but
  who is a family member of such a national or who has derivative rights of residence in exercising treaty rights in
  the UK including:-
  - evidence of the applicant's own identity such as a passport,
  - evidence of their relationship with the European Economic Area family member e.g. a marriage certificate, civil partnership certificate or birth certificate, and
  - evidence that the European Economic Area national has a right of permanent residence in the UK or is one
    of the following if they have been in the UK for more than 3 months:
    - (i) working e.g. employment contract, wage slips, letter from the employer,
    - (ii) self-employed e.g. contracts, invoices, or audited accounts with a bank,
    - (iii) studying e.g. letter from the school, college or university and evidence of sufficient funds; or
    - (iv) self-sufficient e.g. bank statements.

Family members of European Economic Area nationals who are studying or financially independent must also provide evidence that the European Economic Area national and any family members hold comprehensive sickness insurance in the UK. This can include a private medical insurance policy, an EHIC card or an S1, S2 or S3 form.

**Original documents must not be sent to licensing authorities.** If the document copied is a passport, a copy of the following pages should be provided:-

- (i) any page containing the holder's personal details including nationality;
- (ii) any page containing the holder's photograph;
- (iii) any page containing the holder's signature;
- (iv) any page containing the date of expiry; and
- (v) any page containing information indicating the holder has permission to enter or remain in the UK and is permitted to work.

If the document is not a passport, a copy of the whole document should be provided.

Your right to work will be checked as part of your licensing application and this could involve us checking your immigration status with the Home Office. We may otherwise share information with the Home Office. Your licence application will not be determined until you have complied with this guidance.

#### Home Office online right to work checking service

As an alternative to providing a copy of the documents listed above, applicants may demonstrate their right to work by allowing the licensing authority to carry out a check with the Home Office online right to work checking service.

To demonstrate their right to work via the Home Office online right to work checking service, applicants should include in this application their 9-digit share code (provided to them upon accessing the service at <a href="https://www.gov.uk/prove-right-to-work">https://www.gov.uk/prove-right-to-work</a>) which, along with the applicant's date of birth (provided within this application), will allow the licensing authority to carry out the check.

In order to establish the applicant's right to work, the check will need to indicate that the applicant is allowed to work in the United Kingdom and is not subject to a condition preventing them from doing work relating to the carrying on of a licensable activity.

An online check will not be possible in all circumstances because not all applicants will have an immigration status that can be checked online. - Plays: no licence is required for performances between 08:00 and 23.00 on any day, provided that the audience does not exceed 500.
- Films: no licence is required for 'not-for-profit' film exhibition held in community premises between 08.00 and 23.00 on any day provided that the audience does not exceed 500 and the organiser (a) gets consent to the screening from a person who is responsible for the premises; and (b) ensures that each such screening abides by age classification ratings.
- Indoor sporting events: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000.
- Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman
  wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not
  exceed 1000. Combined fighting sports defined as a contest, exhibition or display which combines boxing or
  wrestling with one or more martial arts are licensable as a boxing or wrestling entertainment rather than an
  indoor sporting event.
- Live music: no licence permission is required for:
  - a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
  - a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
  - o a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
  - a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
  - o a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.
- Recorded Music: no licence permission is required for:
  - o any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
  - o any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
  - o any playing of recorded music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.

- Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the
  audience does not exceed 500. However, a performance which amounts to adult entertainment remains
  licensable.
- Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
  - any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
  - o any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
  - any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
  - any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.
