1. Purpose of report:

A review of the premises licence is required following an application for an expedited review under Section 53A of the Licensing Act 2003 (as amended by the Violent Crime Reduction Act 2006).

2. Recommendation:

To consider the review and to determine this matter.

3. Brief Summary of Report:

An application under Section 53A of the Licensing Act 2003 (as amended by the Violent Crime Reduction Act 2006) was received on 3rd November in respect of Arthouse (Scru Club), 54 Bissell Street, Birmingham, B5 7HP.

Compliance Issues: Consistency with relevant Council Policies, Plans or Strategies:

The report complies with the City Council's Statement of Licensing Policy and the Council's Corporate Plan to improve the standard of all licensed persons, premises and vehicles in the City.

5. Relevant background/chronology of key events:

On 3rd November 2017 Superintendent Andrew Parsons, on behalf of West Midlands Police, applied for a review, under Section 53A of the Licensing Act 2003 (as amended by the Violent Crime Reduction Act 2006), of the Premises Licence granted in respect of Arthouse (Scru Club), 54 Bissell Street, Birmingham, B5 7HP.

The application was accompanied by the required certificate confirming that in his opinion the premises are associated with serious crime and disorder. See Appendix 1.

Within 48 hours of receipt of an application made under Section 53A, the Licensing Authority is required to consider whether it is appropriate to take interim steps pending determination of the review of the Premises Licence, such a review to be held within 28 days after the day of its receipt, review that Licence and reach a determination on that review.

Licensing Sub-Committee A met on 6th November 2017 to consider whether to take any interim steps and resolved that the Premises Licence be suspended pending a review of the Licence.

A copy of the decision is attached at Appendix 2.

The review application was advertised, by the Licensing Authority in accordance with the regulations; the closing date for responsible authorities and other parties ended on 17th November 2017.

Due to issues with the Rainbow licence, this event was moved at the last minute to Arthouse Venues, Bissell Street, Digbeth, without police knowledge.

Arthouse Venues had supplied a risk assessment for a Halloween party with an expected audience of 200 customers. The times for this risk assessment were from 22:30 – 02:00 (The terminal hour for licensable activity at this venue on a Tuesday night is 02:00)

Arthouse venues did not communicate with WMP to explain that they were holding this event or any changes to their RA.

Initial investigations suggest there was an obvious issue with capacity, as customers were calling the 999 network to state that the club was so busy that they could not get out. It appeared that the management had totally lost control of the venue.

Following this event, there were no incident reports submitted by the venue.

Today, WMP have been made aware of an incident in the venue where a male has been attacked inside the venue, resulting in his jaw being broken in two places. This incident meets the criteria of serious crime and has been recorded as Inflicting GBH.

This serious crime was avoidable, as this event should not have taken place at Arthouse. The hosting of this event at such short notice seriously undermined public safety which led to a serious crime being committed.

West Midlands Police are seeking the immediate suspension of the premise licence for this venue.

I am a Superintendent in West Midlands Police.

I am giving this certificate because I am in the opinion that the procedures under the Licensing Act are inappropriate in this case because the standard review procedures are thought to be inappropriate due to the seriousness of the crime and disorder, which has led to a male having his jaw broken inside the venue.

The level and seriousness of the incident in terms of the crimes being committed warrant the use of this power.

I have considered the use of the normal review procedure but I do not feel this would be appropriate in these circumstances due to the above reasons, and the fact that to maintain the licensing objective of preventing crime and disorder the normal review procedure would not be sufficient.

The concern of West Midlands Police is that if immediate steps are not taken to consider the operation of this venue then similar incidents could occur.

I am conscious of the guidance contained with the Section 182 guidance around Summary Expedited reviews and given the emphasis that is given to use of this power to tackle serious crime and disorder, my feelings that this process is deemed appropriate are further enforced.

That having considered the application made and certificate issued by West Midlands Police under Section 53A of the Licensing Act 2003 for an expedited review of the premises licence held by Art Venue Ltd in respect of Arthouse, 54 Bissell Street, Birmingham, B5 7HP, this Sub-Committee determines:

that the Licence be suspended pending a review of the Licence,

such a review to be held within 28 days of receiving the Chief Officer of Police's application.

The Sub-Committee's reasons for imposing this interim step are due to concerns raised by West Midlands Police in relation to matters which came to light as a result of an incident during an event held at the premises on Tuesday 31st October 2017, as outlined in the Chief Officer of Police's certificate and application.

The Sub-Committee heard the submissions of West Midlands Police, who confirmed that an investigation had started. A Hallowe'en evening event was being promoted by a national event promoter. The promoter was putting on the same "Hip-Hop Horror Show" night at various licensed premises across the country, including Birmingham. The Birmingham event had been scheduled to be held at licensed premises in Lower Trinity Street. However on the scheduled day, the promoter had wished to change the Birmingham venue at very short notice, and had approached Arthouse, who had agreed to accommodate the event.

Arthouse's operating hours were 1030 hours to 0200 hours – yet the promoter had marketed the event on social media as "1000 hours to 0400 hours". An initial Risk Assessment had been passed to West Midlands Police which stated that the expected attendance for the night was 200 persons, but neither Arthouse nor the independent promoter had informed the Police that the event was being moved from other premises to Arthouse – either in advance of the event, or even the next day. Indeed West Midlands Police had only discovered what had gone on when they were passed an email between a member of the public and the promoter. The Police observed that poor notification of events by Arthouse was an issue that they had previously raised with Arthouse via their solicitors.

On the Friday (3rd November 2017), West Midlands Police were informed of an incident of serious crime and disorder that had happened at the Hallowe'en event – namely that a male patron inside the premises had become involved in an altercation with two other male patrons, which had culminated in an assault in which his jaw was broken. It was suspected by Police that the assault had

1

happened in the first room into which patrons pass as they enter the premises. The patron had been taken to hospital, and it was thought that he had had to have his jaw wired, and/ or a steel plate inserted in his jaw. He also had associated injuries such as face swelling. He was not yet well enough to give a statement to Police.

It was the recommendation of West Midlands Police that the licence be suspended whilst the Police investigated. It was the initial view of West Midlands Police that Arthouse had taken on somebody else's event at very short notice, for which they were not prepared, and as a result there had been an episode of serious crime and/ or disorder. Arthouse had not informed the Police of the venue change in advance; nor had the Police had any contact from Arthouse on the night. The only 999 calls received were from patrons of the premises, about other issues (not the broken jaw assault). The Police had not found out what had happened until after the event. The door staff had been informed of the incident at the time, but the two men were not stopped, and they left the premises.

The Sub Committee determined that the potential causes of the incident appeared to originate from inadequate internal management procedures at the premises, such that a patron appeared to have been attacked by others and had suffered a serious injury requiring hospitalisation and surgery. The Sub-Committee was particularly concerned to hear that although West Midlands Police had requested the CCTV, the premises licence holder had been unable to produce it, which was wholly unsatisfactory in circumstances where serious crime/ disorder had occurred. During the meeting it became apparent that there were problems over the operation of the CCTV in general – several cameras were thought to have been offline on the night, which caused the Police to question whether the premises was in fact operating without the CCTV arrangements which are a condition of their licence.

The premises, via their legal representative, urged the Sub-Committee not to suspend the Licence; they considered that the issues could be managed by the imposition of additional conditions, such that the premises could continue to operate. However the premises accepted that the Risk Assessment had not been done correctly, and also that there were some problems surrounding the operation of the CCTV, with which Arthouse's CCTV consultant was assisting.

Having heard the premises' account, the Sub-Committee determined that it was both necessary and reasonable to impose the interim step of suspension to address the immediate problem with the premises, in particular the likelihood of serious crime and or serious disorder, and to promote the prevention of crime and disorder objective in the Act.

The Sub-Committee considered whether it could impose any other interim step, including modification of licence conditions, or exclusion of the sale of alcohol by retail or the removal of the Designated Premises Supervisor. The Sub-Committee did not believe however that any of these would address the seriousness of an assault in which a patron had his jaw broken. The risks could only be addressed by the suspension of the Licence as an interim step.

In reaching this decision, the Sub-Committee has given due consideration to the City Council's Statement of Licensing Policy, the Guidance issued by the Home Office in relation to expedited and summary licence reviews, and the submissions made at the hearing by the Police, by the legal representative for the premises, and by the premises licence holder.

All parties are advised that the premises licence holder may make representations against the interim steps taken by the Licensing Authority. On receipt of such representations, the Licensing Authority must hold a hearing within 48 hours (excluding non-working days).

All parties are advised that there is no right of appeal to a Magistrates' Court against the Licensing Authority's decision at this stage.

4 Public Health response

Licensing Objective Response	
The prevention of crime and disorder	There have been clear breaches of conditions of licence, conditions that are in place to prevent crime and disorder. There has been a fundamental breakdown in the ability of the venue to be able to promote these conditions, and therefore to be able to promote the very objective to prevent crime and disorder.
	This is a venue that has allowed an event to take place that did not have permission to take place, not because it was refused, but because the venue chose not to inform West Midlands Police, and submit a risk assessment. The failure of the venue to adhere to its conditions of licence led to the event taking place, being out of control, and culminating in one person having their jaw broken in two places, and needed urgent hospital treatment. This was wholly avoidable.
	There is a specific condition that states the following:
	"All events to be held at the premises are to be risk assessed". This simply did not happen. This is a serious breach of this condition, and a fundamental failure to promote the objective to prevent crime and disorder.
	Did West Midlands Police receive a notification of this event at least 28 days prior to the event taking place? (We seek clarification). If notification was not received then this is another breach of conditions of licence.
	We are disappointed and disturbed by the fact that the serious crime that took place within the premises was not reported to West Midlands Police by the premises.
	This is an area (at LSOA level) that our alcohol tool registers as red for alcohol related crime. It is also registered as red for alcohol related hospital admissions – this is an area where alcohol is a problem. Licence holders should be setting a precedent in promoting the very objectives designed to reduce these issues, and should certainly not be contributing to them.

Public safety	This is the Second City, it is a young city, and therefore attracts many young people to events such as the one that we are discussing today, it is of paramount importance the we promote public safety at every opportunity, and even more fundamentally if this is in fact a condition and an objective that you have agreed upon in your application for an alcohol licence, and have subsequently obtained on the basis that you will indeed promote the objectives and conditions. It is our opinion that there is no place in Birmingham for licence holders who cannot promote public safety, and therefore guarantee public safety, especially when this means that people feel so threatened in an environment that they have to call 999 to inform the emergency services that it is so overcrowded that they cannot get out. It would seem that this is an event that was promoted to run until 4am. The condition of licence states that events occurring on a weeknight are only licensed until 2am. If after clarification from the committee and supporting officers that it is the case that the event was running after 2am then this is another fundamental and separate breach of the conditions of licence. (we seek clarification)

Summary		
It would seem that there is a cumulative impact with reference to the inability of the licence holder to be able to promote the licensing objectives, and the conditions attached to the licence. We have no confidence that the licence holder can promote the specific objectives of preventing crime and disorder, and promoting public safety, this is apparent because of the breaches of conditions that have taken place, specifically relating to not informing West Midlands Police that the event would be taking place, not providing a risk assessment, not reporting a serious crime (we don't consider "not knowing that it took place" as being a defence. It is up to the venue to know about these things, and indeed to prevent them from happening in the first instance.		
There was the real and significant risk to the safety of the public due to overcrowding, and also due to there being no risk assessment consultation with West Midlands Police, and also due to not notifying the police of the event in any instance.		

The venue was clearly operating outside of its conditions, and was not able to promote the very conditions that are there to prevent crime and disorder, and to promote public safety. We urge the committee to consider whether this venue, and licence holder are able to promote the conditions to protect the public from crime and disorder, and to ensure public safety.

We also suggest that the committee consider, on the balance of probability, if it has any confidence in the ability of the venue and the licence holder to be able to promote the other objectives, to protect children from harm, and to prevent public nuisance, given that they

Within a one mile radius of the venue, and in one month (August 2017) there have been 1456 individual crimes recorded for that month, including 301 for ASB, 24 Drugs, 10 possession of weapons, 74 public order, 280 violence & sexual offences. Due to the inability of the venue and the licence holder to be able to promote their objectives and fulfil their conditions, they are contributing to these statistics, this is not acceptable.

5 Supporting Evidence and Information

5.1 Public Health Statistical Analysis

The statistical analysis in Appendix 1 has determined a **HIGH RISK rating (RED) against a series** of key alcohol related crime offences.

This rating is based upon an analysis of a range alcohol related datasets through our Alcohol Risk Assessment Tool. This allows Public Health to place the premises' postcode into the tool and assess against the surrounding area, compare against the Birmingham LSOA average, examine the larger Ward area and impact within the district.

In particular, there is a high concentration of on- and off-license premises in this area and analysis has rated domestic violence as RED / HIGH RISK.. There are also commissioned alcohol misuse treatment services nearby.

It is important to note that the figures provided show statistical significance, meaning they are RAG rated by whether this LSOA is any better or worse than the average of all other LSOAs. As such, some figures show an AMBER or GREEN rating even though they may represent significant risk or have a high number of incidents in that area – the figures themselves are high, but the area may not be any worse than the average LSOA rating.

A clear example is Police (Non-Domestic Violence) which has been rated as GREEN (better than Birmingham's LSOA average); however, incidents are recorded as 124 for this area which represents a significant risk to health and is therefore rated as HIGH RISK.

Please note: Birmingham is made up of 10 districts with approximately 100,000 people in each; each district contains four ward of approx. 25,000 people; each ward contains approx. 20-25 LSOAs (lower super output area) of approximately 1,000 -1,500 people in each.

5.2 Crime

In August 2017, West Midlands Police reported 1456 individual crimes for that month, within a 1 mile radius of the property. These breakdown into several categories, a sample of which are below:

- Anti-social behaviour 301

Figure 3 in Appendix 3 shows the immediate vicinity around the premises and crimes recorded. 22 incidents were recorded in August 2017 in the same or neighbouring roads and included robbery, theft, violence/sexual offences, anti-social behaviour and public order

It is important to note that these are one month's figures.

The table below shows the number of recorded crime within 1 mile radius of the premises by month. It is clear that this area has a high crime rate which should be taken into consideration when considering the premises ability to uphold the licensing objectives.

5.3 Transport Links

Access to public transport may become a consideration where premises are situated in residential areas (and customers will have to walk through the same residential areas to access transport) or where there are limited transport links resulting in large groups of people waiting for collection or walking through estates further.

In this instance, the premises are within the city centre boundaries within easy distance of several all-night buses, local buses, train stations (Moor Street and New Street) and main road connections (e.g. Bristol Street). This makes the premises easily accessible over a 24 hour period.

5.4 Impacts on economic activity

From a *public safety* pillar perspective, we're concerned that this type of criminal behaviour could deter investment, job creation, employment sustainability and the opportunity to socialise as part of

the night-time economy. Public Health outcomes, especially in the context of the wider and social determinants depend on a number of factors; two of these key factors are the creation and sustainability of safe environments and opportunities for employment.

5.5 Conditions of License

The premises conditions of license clearly state the West Midlands Police must be notified of all events happening within 7 days of the events and all late night events must be risk assessed within 28 days of the events.

The statement provided by the West Midlands Police states an event was risk assessed but they were not notified of the changes to the event when the Rainbow event moved to the Arthouse, and of the extended opening hours (the original risk assessment started closing at 2am, however the Rainbow event was advertised to run until 4am).

Failure to notify the Police of the changes and complete a revised risk assessment based on the additional numbers expected and timings of the event led to the venue staff "losing control" of the event, causing overcrowding and panic (calls were made to 999 stating they were unable to get out). Had this event been properly assessed and managed, the subsequent assault could have been prevented.

The Police statement also draws attention to the fact the club did not report the incident (a condition of license).

Failure to meet these conditions and uphold the licensing objectives is a serious breach of license.

Appendix 1. Public Health Data Analysis

Interpretation of this document:

Variable geographical levels of information have been used where available, in each case this is based on the post code of the application falling within this larger geographical area. Two terms are less commonly used outside of certain specialist areas and are detailed below:

- LSOA (Lower Super Output Area) is a geographical Census area with an approx. population of 1,500.
- MSOA (Medium Super Output Area) is a geographical Census area with a approx. population of 8,000.

Scores have been calculated by comparing the geographical area in question to the average at a higher level (Birmingham in most instances). 10% margin of error has been applied to both the smaller and larger areas and it is only where these are still relatively different that a RED (more prevalence or risk in area compared to average) or GREEN (less prevalence or risk in area compared to average) score has been calculated. Where these margins for error overlap in any way this has been calculated as AMBER (indifference).

1 Tier One Data Overall LSOA Score: <u>RED / HIGH RISK</u>

This score has been generated based on information regarding alcohol related violence and domestic violence, existing on-licences and off-licences, alcohol related fires, alcohol related safeguarding, underage sales and the existence of a cumulative impact area. These elements have been viewed as having the largest measurable impact on whether the licence should be granted and actual numbers were made available on a low level geography. The score is by quartiles and these are colour coded worst to best as Red, Amber, Yellow, Green. Full details below.

Whilst Alcohol Related Ambulance Activity is viewed as Tier One data it has not been possible to include it in the overall LSOA score as the data is only available on a post code district level.




Figure 1: Map showing all recorded crime in August within 1 mile of the premises




Figure 3: Map showing all crime recorded in August 2017 within the immediate vicinity of the premises




Figure 5: Map showing the location of public transport routes in relation to the premises



#### Annex 1 - Mandatory Conditions

No supply of alcohol may be made under the premises licence (a) at a time when there is no designated premises supervisor in respect of the premises licence, or (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

Every retail sale or supply of alcohol made under this licence must be made or authorised by a person who holds a personal licence.

The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises. In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises- (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to- (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or (ii) drink as much alcohol as possible (whether within a time limit or otherwise); (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective; (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective; (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner; (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).

The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.

The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol. The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy. The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either— (a) a holographic mark, or (b) an ultraviolet feature.

The responsible person must ensure that— (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures— (i) beer or cider: ½ pint; (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and (iii) still wine in a glass: 125 ml; (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available."

(1) A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price. (2) In this condition:- (a) "permitted price" is the price found by applying the formula  $P = D + (D \times V)$ , where- (i) P is the permitted price, (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol, and (iii) V is the rate of the sale or supply of the alcohol; (b) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979; (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence- (i) the holder of the premises licence, (ii) the designated premises a supply of alcohol under such a licence; (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994. (3) Where

the permitted price would not be a whole number of pennies, the permitted price shall be taken to be the price rounded up to the nearest penny. (4) Where the permitted price on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax, the permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

The admission of children under the age of 18 to film exhibitions permitted under the terms of this licence shall be restricted in accordance with any recommendation made: (a) By the British Board of Film Classification (BBFC), where the film has been classified by that Board, or (b) By the Licensing Authority where no classification certificate has been granted by the BBFC, or, where the licensing authority has notified the licence holder that section 20(3)(b) (s74(3)(b) for clubs) of the Licensing Act 2003 applies to the film.


