**1. Purpose of report:**

To consider a relevant representation that has been made in respect of an application to vary the Premises Licence which seeks to extend the hours for the Sale of Alcohol (for consumption on and off the premises), to operate from 11:00am until 12:00midnight (Monday to Sunday).

The application initially sought to extend the provision of Regulated Entertainment consisting of recorded music, to operate indoors only, from 11:00am until 01:00am (Sunday to Wednesday) and 11:00am until 02:00am (Thursday to Saturday).

Due to an administrative error in the public notice, the applicant has removed the proposal to extend the hours for the playing of recorded music from the scope of the application.

The provision of late-night refreshment, to operate from 11:00pm until 01:00am (Sunday to Wednesday) and 11:00pm until 02:00am (Thursday to Saturday).

Premises to remain open to the public from 11:00am until 01:30am (Sunday to Wednesday) and 11:00am until 02:30am (Thursday to Saturday).

Other dates and times are specified in the application form.

To the Licensing Department,

I am writing as a local resident and active community member to formally object to the application (Ref: 215692) by BURGER-ME-UP LTD to extend their licensing hours to 1:30 AM.

As someone who works in this area and is involved with local community safety groups, I see firsthand the challenges our streets face. I believe this extension will cause significant chaos and harm to the neighborhood based on the following:

1. Prevention of Public Nuisance

A 1:30 AM closing time is excessive for the Pershore Road/Bournville area. This extension will cause persistent annoyance and disturbance to residents. It isn't just about the noise inside the building; it is about the "chaos" outside—shouting, slamming car doors, and delivery bikes—continuing until nearly 2:00 AM. This is unfair to residents who need rest.

2. Impact on New Housing and Vulnerable Residents

New flats are being developed nearby specifically for people requiring accommodation and support. These residents, many of whom may work shift patterns or have specific wellbeing needs, require a quiet environment to sleep. Introducing a late-night alcohol and food hub until 1:30 AM directly undermines the suitability of these new homes.

3. Public Safety and Crime & Disorder

Through my involvement with local security groups and community social media, I am aware of the existing issues with antisocial behavior in this corridor. Extending the hours will only attract more "alcohol-related junk" and late-night loitering. It is not "fair" to ask the local community or the police to manage the increased risk of disorder that a 1:30 AM license would bring to this specific location.

4. Conclusion

The applicant should stick to their original, standard opening hours. The jump to 1:30 AM is a step too far for a residential community. I urge the Licensing Committee to refuse this variation in full.

**a) General – all four licensing objectives (b, c, d and e) (please read guidance note 11)**

The premises operates as a counter-service burger restaurant providing seated dining, takeaway and delivery services. Alcohol is supplied both for consumption on the premises and for takeaway or delivery during permitted hours. The premises is food-led and alcohol sales remain ancillary to the primary restaurant operation.

A small number of external benches may be provided at the frontage of the premises within the premises boundary. We will submit a licensable area for these after successful submission and acceptance of this application.

These will be positioned so as not to obstruct the adjacent public pathway and will be monitored by staff to ensure appropriate customer behaviour and noise levels.  
Delivery drivers utilise a separate entrance and collection point to minimise congestion and ensure safe and orderly operation at the premises.

Staff are trained in responsible alcohol retailing and the premises operates a Challenge 25 policy.

**b) The prevention of crime and disorder**

The premises will operate a Challenge 25 policy and staff will request valid photographic identification where required. Staff receive training on responsible alcohol sales and the refusal of service to intoxicated individuals.

Management will monitor customer behaviour both inside the premises and in the external seating area. Any disorderly behaviour will be addressed promptly by staff.

The benches will be moved inside at the end of the night to prevent loitering or any unwanted behaviour.

The premises will maintain good working relationships with local authorities and police where necessary

**c) Public safety**

The premises will comply with all relevant health and safety legislation. Staff are trained in emergency procedures and safe customer management.

Customer areas, including any external seating benches, will be kept clear and safely arranged to avoid obstruction to pedestrian access. Delivery drivers collect orders via a designated separate entrance to reduce congestion.

**d) The prevention of public nuisance**

Management will monitor noise levels from customers to ensure they remain reasonable for the surrounding area. Customers using the external benches will be reminded to respect neighbouring properties and the local community.

The premises will ensure the frontage and surrounding area are regularly checked and kept clean. Any litter, spillages, or breakages such as glass will be cleared immediately by staff.

**e) The protection of children from harm**

The premises operates a Challenge 25 policy and only accepts recognised forms of photographic identification such as a passport or photocard driving licence.

Children are permitted on the premises when accompanied by an adult. The premises does not provide any form of adult entertainment or activities unsuitable for minors.

**Annex 1 – Mandatory Conditions**

No supply of alcohol may be made under the premises licence (a) at a time when there is no designated premises supervisor in respect of the premises licence, or (b) at a time when the designated premises supervisor does not hold a personal licence, or his personal licence is suspended.

Every retail sale or supply of alcohol made under this licence must be made or authorised by a person who holds a personal licence.

The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol. The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy. The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either - (a) a holographic mark, or (b) an ultraviolet feature.

(1) A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price. (2) In this condition: - (a) permitted price is the price found by applying the formula  $P = D + (D \times V)$ , where - (i) P is the permitted price, (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty charged on the date of the sale or supply of the alcohol, and (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol. (b) duty is to be construed in accordance with the Alcoholic Liquor Duties Act 1979. (c) relevant person means, in relation to premises in respect of which there is in force a premises licence - (i) the holder of the premises licence, (ii) the designated premises supervisor (if any) in respect of such a licence, or (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence. (d) relevant person means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and (e) value added tax means value added tax charged in accordance with the Value Added Tax Act 1994. (3) Where the permitted price would not be a whole number of pennies, the permitted price shall be taken to be the price rounded up to the nearest penny. (4) Where the permitted price on a day (the first day) would be different from the permitted price on the next day (the second day) as a result of a change to the rate of duty or value added tax, the permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

Each individual assigned to carrying out a security activity must be licensed by the Security Industry Agency.

**Annex 2 – Conditions consistent with the Operating Schedule**

The Licence Holder must ensure staff will be trained to recognise and handle potentially disorderly behaviour. This includes the responsible service of alcohol, conflict resolution, and how to refuse service to intoxicated or underage customers.

The Licence Holder must install CCTV cameras and ensure adequate lighting in and around the premises.

The Licence Holder will ensure install a monitored grade 2 alarm system, enabling an immediate police response where required.

The Licence Holder must ensure staff will be trained to enforce ID checks to prevent underage drinking, using 'Challenge 25!'.

The Licence Holder must ensure to establish and enforce a clear zero-tolerance policy against drug use, weapons, and aggressive behaviour. The Licence Holder will display signage to communicate our rules to customers.

The Licence Holder must ensure the use of a logbook to maintain a record of any incidents of disorder, refusal of service, or ejections from the premises. This will help in both managing issues and providing evidence to the authorities if required.

Regularly inspect the premises to ensure we are compliant with health and safety regulations, fire safe, structurally sound and clean.

The Licence Holder will monitor and control the number of customers to avoid overcrowding during busy periods.

The Licence Holder must ensure staff will be trained for emergency evacuation and fire exits will be clearly marked and unobstructed.

The Licence Holder will keep a well-stocked first-aid kit on the premises and ensure that some staff members are trained in basic first aid.

There will be a first aid procedure in place for designated first aiders to ensure public safety in worst-case scenarios.

The Licence Holder will maintain clear, well-lit pathways, and promptly address any spills or hazards to prevent accidents.

The Licence Holder will implement measures to minimize noise, such as regulating the music volume and using soundproof plasterboard to board the ceilings and walls.

Ensure proper disposal of waste and provide adequate commercial bins inside and outside the premises to prevent littering and the congregation of waste.

The Licence Holder will manage the behaviour of customers leaving the bar by encouraging them to do so quietly and respectfully. We will have a sign near the exit to remind customers of nearby homes and to exit the venue quietly at night.

The Licence Holder will build and maintain good relations with local residents by keeping them informed of any events or changes to operations that might affect them.

As we build relations with local residents, we will also address any complaints and/or issues politely and as required.

**BIRMINGHAM CITY COUNCIL**

Implement a robust age verification policy (Challenge 25) to ensure that no underage individuals are served alcohol. We will train our staff on the severe importance of checking IDs.

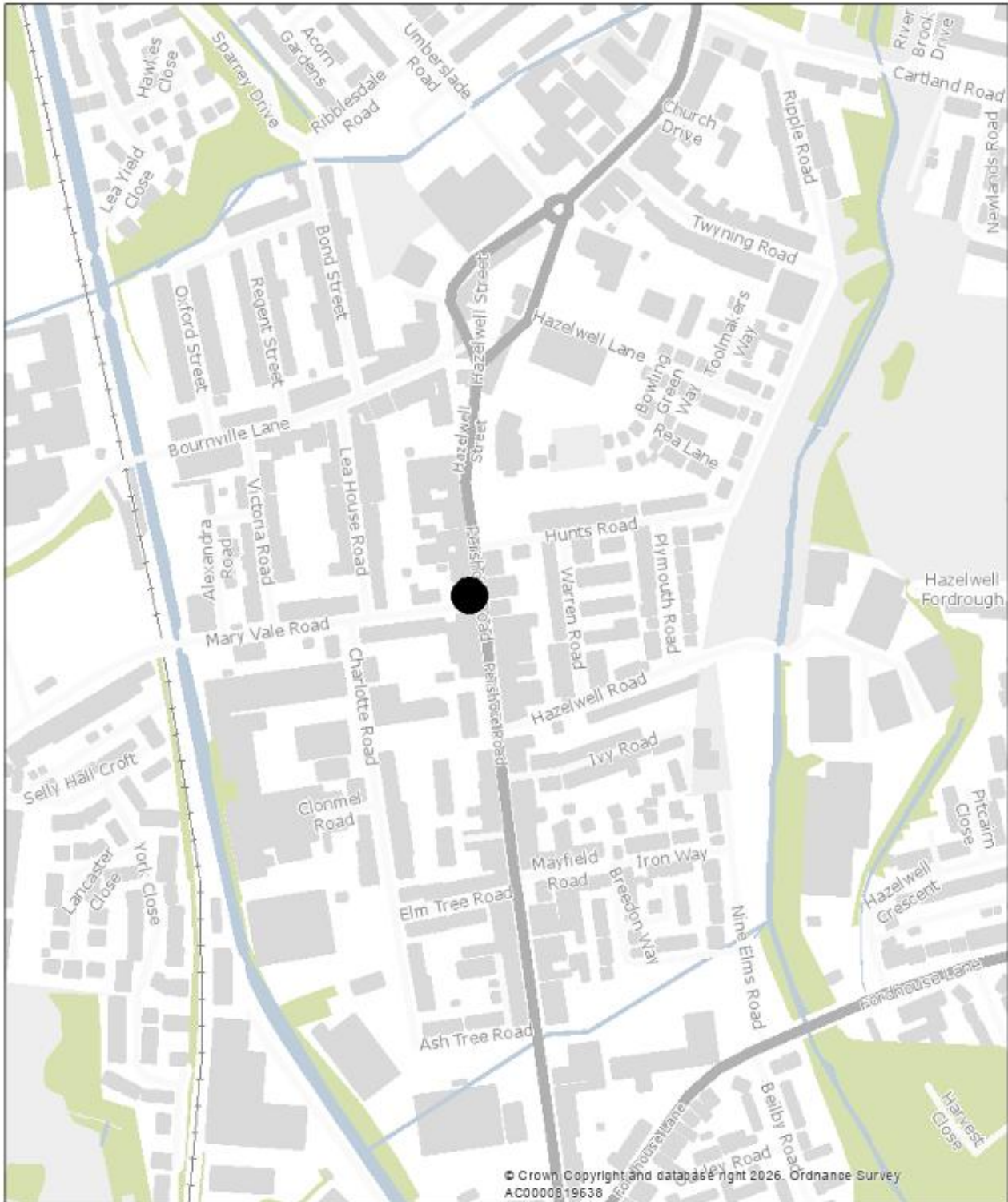

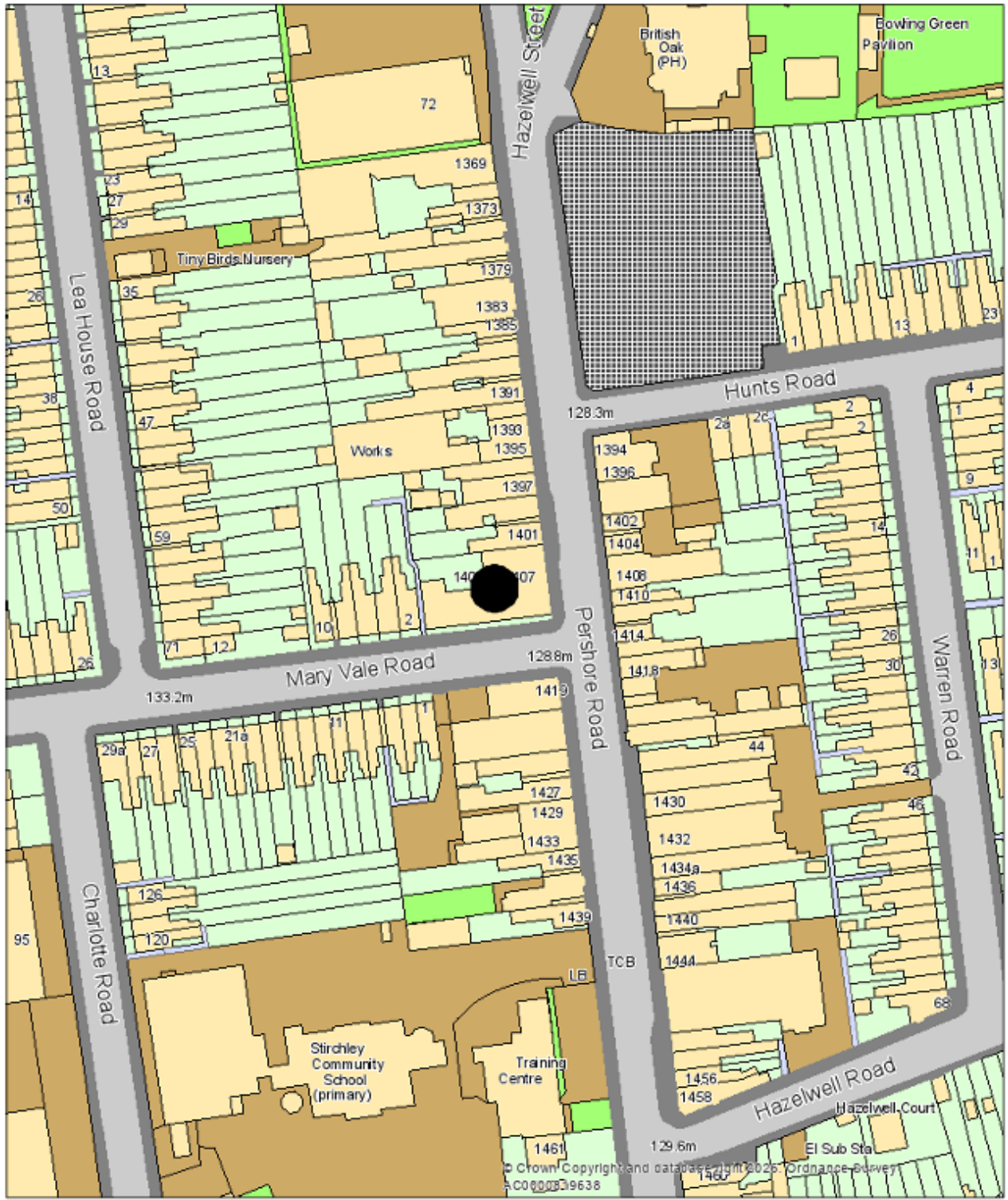
