3. Brief Summary of Report:

Review application received on 3rd December 2019 from Birmingham City Council Licensing Enforcement in respect of BBQ Village Chinese Restaurant T/A Tasty Restaurant, 55 Station Street, Birmingham, B5 4DY.

A representation has been received from West Midlands Police as a responsible authority.

The report complies with the City Council's Statement of Licensing Policy and the Council's Corporate Plan to improve the standard of all licensed persons, premises and vehicles in the City.

5. Relevant background/chronology of key events:

Birmingham City Council Licensing Enforcement applied on 3rd December 2019 for a review of the Premises Licence under Section 51 of the Licensing Act 2003 for BBQ Village Chinese Restaurant T/A Tasty Restaurant, 55 Station Street, Birmingham, B5 4DY.

A representation has been received from West Midlands Police, as a responsible authority. See Appendix 1.

Review application is attached at Appendix 2.

The Premises Licence is attached at Appendix 3.

Site location plans are attached at Appendix 4.

The details of the review application give evidence of criminal activity taking place, namely employing illegal workers.

I have visited the premises on two occasions since the discovery of the illegal workers. The DPS and licence holder are long term away from the business, giving me significant concern that anyone is accountable for promoting the licensing objectives. The premises did not engage positively on the visits and no one appeared to be taking responsibility for managing the venue.

It appears that the current operators of the premises have no regard for the licensing objectives, causing WMP concern that bad practice will continue.

On the 6th November 2019 Acting on intelligence, Officers from the Licensing Enforcement, Home Office Immigration Enforcement and West Midlands Police visited BBQ Village Chinese Restaurant, 55, Station Street. Upon entry a number of people were observed working at the premises,

Immigration Enforcement Officers spoke to various individuals and checks were made to establish whether they had the required permission to work in the UK. 3 males and 2 females were subsequently detained at the scene for immigration breaches.

Further checks have been conducted by Home Office immigration and the immigration status of persons detained has been established:-

Para 11.27:-

There is certain criminal activity that may arise in connection with licensed Premises which should be treated particularly seriously. These matters include the use of the licensed premises:

 for knowingly employing a person who is unlawfully in the UK or who cannot lawfully be employed as a result of a condition on that person's leave to enter;

Immigration, Asylum and Nationality Act 2006 - Section 21 states:-

(1) A person commits an offence if he employs another ("the employee") knowing that the employee is an adult subject to immigration control and that—

- (a) he has not been granted leave to enter or remain in the United Kingdom, or
- (b) his leave to enter or remain in the United Kingdom-
 - (I) is invalid,

 (ii) has ceased to have effect (whether by reason of curtailment, revocation, cancellation, passage of time or otherwise), or
 (iii) Is subject to a condition preventing him from accepting the employment.

Immigration Act 1971 - Section 25 states;-

Assisting unlawful immigration to member State

(1)A person commits an offence if he-

- (a) does an act which facilitates the commission of a breach or attempted breach of immigration law by an individual who is not a citizen of the European Union,
- (b) knows or has reasonable cause for believing that the act facilitates the commission of a breach or attempted breach of immigration law by the individual, and
- (c) Knows or has reasonable cause for believing that the individual is not a citizen of the European Union.

This review application is being made on the grounds that an illegal workers have been identified working at BBQ Village Chinese Restaurant, 55, Station Street which amounts to criminal activity and seriously undermines the licensing objectives contained in the Licensing Act 2003 regarding:-

• The prevention of crime and disorder;

I therefore feel we should seek to get the Premises Licence revoked

Please provide as much information as possible to support the application (please read guidance note 3)

On Wednesday 6th November 2019 at 16:26 hours a joint visit was made to licensed premises trading as Tasty Restaurant, 55, Station Street, Birmingham, B5 4DY

Officers from the following Responsible Authorities supported this visit;-

- Home Office Immigration Enforcement;
- Licensing Enforcement.
- West Midlands Police

During the visit immigration officers spoke to a number of people working at the premises and identified 3 males and 2 females who were detained by immigration officers for possible immigration breaches. Subsequently investigations have established that all the persons detained were over stayers and they did not have the required permission to work in the UK.

From a Licensing Enforcement viewpoint the owner of the Premises Licence Mr. YANG CHENG was not present or contactable, no staff members present would own up to being in charge, they were uncooperative and unhelpful stating that they are only workers they did not know anything. A male identified as WAI CHUNG CHENG who appeared in charge (even though he said kitchen staff had keys to open & close restaurant) was unable to produce the "Premises Licence" and advised he did not know where it is kept and was not aware of the attached conditions of licence, WAI CHUNG CHENG advised that YANG CHENG was still in control of the business, but he was out of the country, I was informed he did not know who had authorised the sale of alcohol, WAI CHUNG CHENG advised me that he was a personal licence holder, but was unable to produce his personal licence identity card on request. I was informed that he did not have YANG CHENG contact details. Therefore I was unable to check if the premises were compliant with the conditions of licence. I left my contact details with a female who identified herself as CHAOGIN ZHAO requesting that YANG CHENG contact me as soon as possible. I have had no contact from YANG CHENG

On the 18th November 2019 at 14:00pm in-company with Licensing Enforcement Officer Shaid Ali and West Midlands Police Officer 2413 Ben Reader we visited Tasty Restaurant, 55, Station Street, Birmingham, B5 4DY. I spoke to WAI CHUNG CHENG who advised he was in charge, I asked him if he was able to produce the "Premises Licence " and was informed no, PC Reader asked when was the last time YANG CHENG had been at the premises, WAI CHUNG CHENG said " he had not been there for years, we don't contact him he contacts us" I asked him if the premises had CCTV as per the conditions of licence and was advised " has not been there for years"

From visits and findings it would appear the YANG CHENG has lost control of the running of the business, and has not left a responsible person in charge in his absence. YANG CHENG is not taking his responsibilities seriously and not promoting the licensing objectives, as such I have no confidence in him as the Premises Licence Holder and Designated Premises Supervisor.

Home Office Immigration civil penalty team has served a Notice of Potential Liability on YANG CHENG being the business owner, (which could result in fines up to £20,000 per person illegally working)

It is an offence under Immigration, Asylum and Nationality Act 2006 to knowingly employ a person if the employee has not been granted leave to enter or remain in the UK.

It is a further offence under Section 25 Immigration Act 1971 to do anything to facilitate another person's illegal entry, transit or stay in the UK.

All employers have a duty to prevent illegal working, and a responsibility to conduct relevant document checks to ensure they only recruit people who have permission to lawfully work in the UK.

Where a licence holder / business owner is prepared to employ illegal workers they are not only committing offences but are also actively involved in criminal activity and the exploitation of extremely desperate and vulnerable individuals for financial gain.

- Illegal workers have no employment rights or protections and are unable to declare themselves to the authorities to seek assistance should they require any assistance.
- Illegal workers have no rights to be paid the equivalent of the minimum wage which benefits the employer financially.
- Illegal workers are often paid 'cash in hand' by the employer meaning the correct tax and national insurance deductions are not taken into account, and therefore not declared to HMRC.
- Illegal workers are often provided with the most basic accommodation and standard of living which may be linked to their continued employment at the licensed premises.
- Illegal entrants into the UK will not have been subject to the usual immigration checks and health screenings and this could seriously impact on public protection and the health and wellbeing of the general public, especially where illegal entrants have arrived from a country with significant health risks. The employment of such individuals poses on an increased risk especially if that person is employed in a kitchen, or an area where food is prepared or served to the public.
- illegal entrants also do not undergo any appropriate checks, or immigration clearance at the border and may have current or previous criminal convictions and thereby pose a danger for the general public.

During the inspection the following matters were identified contrary to Licensing Act 2003.

- Section 57 (7) failure to produce the premises licence or certified copy for inspection to authorised officer on request
- Section 136 Carrying on licensable activities other than in accordance with an authorisation
- As and when necessary or judged appropriate, the Licensee and/or staff shall liase with the Police so as to promote the prevention of Crime and Disorder
- No CCTV system in place on the premises

The Licensing Act 2003 is clearly intended to prevent crime and disorder in relation to premises, as well as deter and prevent unscrupulous persons from operating illegally under the authorisation of a premises licence.

Employing illegal workers has far reaching harmful social and economic effects within the UK. It enables dishonest employers to take advance and exploit extremely desperate and vulnerable individuals for financial profit and to gain an unfair advantage over competitors who operate legally and comply within the laws of the United Kingdom.

Other relevant information; It has come to my attention that Tasty Restaurant 55, Station Street, Birmingham, B5 4DY is currently liable for non domestic business rates debt.



Annex 1 - Mandatory Conditions

No supply of alcohol may be made under the premises licence (a) at a time when there is no designated premises supervisor in respect of the premises licence, or (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

Every retail sale or supply of alcohol made under this licence must be made or authorised by a person who holds a personal licence.

There was no application to remove any of the embedded restrictions applicable to this licence under the old licensing regime. Those embedded restrictions are detailed below. Licensable activities may continue beyond the times specified in the embedded restrictions up to the times the premises licence authorises the carrying out of licensable activities.

Permitted hours - Alcohol may be sold or supplied: (1) On weekdays, other than Christmas Day, Good Friday or New Year's Eve from 11am to 12pm. (2) On Sundays, other than Christmas Day or New Year's Eve, and on Good Friday: 12 noon to 11:30pm (3) On Christmas Day: 12 noon to 11:30pm; (4) On New Year's Eve, except on a Sunday, 11 am. to midnight; (5) On New Year's Eve on a Sunday, 12 noon to 11.30 pm. (6) On New Year's Eve from the end of permitted hours on New Year's Eve to the start of permitted hours on the following day, which would be 11.00 am. if New Year's Day falls on a weekday or 12 noon if a Sunday.

Alcohol shall not be sold or supplied: (a) unless the premises have been structurally and bona fide used, or intended to be used, for the purposes of habitually providing the customary main meal at midday or in the evening, or both, for the accommodation of persons frequenting the premises; (b) on the premises otherwise than to persons taking table meals there and for consumption by such a person as an ancillary to his meal.

Alcohol shall not be sold or supplied unless suitable beverages other than alcohol (including drinking water) are equally available for consumption with or otherwise as an ancillary to meals served in the premises.

Annex 2 – Conditions consistent with operating schedule

2a) General conditions consistent with the operating schedule

The provision of regulated entertainment and late night refreshment to take place indoors only.

No adult entertainment or services permitted on the premises.

2b) Conditions consistent with, and to promote the prevention of crime and disorder

Staff refuse to sell alcohol to under age persons and anyone who appears to be drunk.

Excessive drinking is discouraged.

Staff are trained to remain calm and not react to provocation.

Staff are vigilant about the possible misuse of the premises for drug dealings.

As and when necessary or judged appropriate, the Licensee and/or staff shall liaise with the Police so as to promote the Prevention of Crime and Disorder.

2c) Conditions consistent with, and to promote, public safety

Anti-social and destructive behaviour is discouraged.

'Happy hours' are not permitted under the authority of this licence.

First Aid is available on the premises.

Patrons are prevented from carrying out glasses and bottles from the premises.

Where appropriate age restrictions are in place, including age verification checks.

A C.C.T.V. system is in place on the premises.

2d) Conditions consistent with, and to promote the prevention of public nuisance

All staff behave, responsibly.

Service is refused to persons under age and anyone who appears to be drunk.

Any destructive or noisy behaviour is discouraged and, if appropriate, reported to the Police.

Any suspicious activity (i.e. drug dealings in the proximity of the premises) is reported to the Police.

2e) Conditions consistent with, and to promote the protection of children from harm

Persons under the age of 14 are not permitted in the area of the Bar.

The Licensee shall ensure that, if appropriate, age verification checks are carried out.





With regard to the application submitted by Mr Rahman for the grant of a premises licence at the above premises, Licensing Enforcement received a complaint regarding the premises on 17/06/2019 alleging the premises were carrying out licensable activities without a licence mainly the serving of alcohol.

A visit to the premises was conducted by Licensing Enforcement in July 2019 in company of colleagues from Environmental Health, West Midlands Police and West Midlands Fire Service, the following matters were identified -

Gary Callaghan Licensing Enforcement Officer gave advise to the premises writing on traders notice 25836/7 by Licensing enforcement regarding the requirement to obtain a premises licence for licensable activities after a speaker was playing recorded music and alcohol was found in a fridge and also in the hallway, see attached photos.

Steve Graham Fire Safety Inspecting officer identified the following matters -

- The rear fire exit door was covers by a roller shutter. This exit is required due to the depth of the building.
- The fire alarm and detection system was not working due to having no power going to the alarm panel. It had not been serviced for some time. The fire extinguishers had not need serviced.
- Although a fire risk assessment need not be recorded, the owner had not carried one out. I will be sending a letter the business owner and the landlord to get the issues sorted.

Alison Whelan From Environmental Health identified the following matters -


- They were warned and given advisory information regarding the Sheesha (smoking in a smoke free premises)
- Due to the presence of cockroaches in the premises and the fact that it was operating as a food business the
 premises was served with a Hygiene Emergency Prohibition Notice to cease trading. A revisit was conducted
 on 11/07/19 and has shown that cockroaches are still active so a Hygiene Emergency Prohibition Order was
 granted to cease the premises until the risk to health has been removed.
- I have a suspicion they may have traded but at the moment it is only a suspicion.


I am aware that complaints have been made to Environmental Health about noise emanating from the premises but they have been unable to investigate the matter as it is my understanding that the complainant did not wish to make the matter formal.

I have seen the conditions that have been agreed with West Midlands Police and these do go some way towards measures that will ensure the premises uphold the licensing objectives however licensing enforcement do still have concerns given the previous issues identified and will be seeking further information to be submitted from responsible authorities regarding the current situation, due to annual leave I have been unable to clarify this matter with them currently.

There is a strong management and security procedures in place which encompasses the four licensing objectives as below. A Challenge 25 policy will be strictly followed by all staff. Staffs are trained as appropriate in respect of relevant licensing law. The open nature of the cafe allows for good viewing coverage. CCTV is installed on the premises.

b) The prevention of crime and disorder

CCTV is installed inside the premises. CCTV will be recording at all times the premises are open for any licensable activities and images will be held for a minimum of 28 days and made available immediately on request by any of the Responsible Authorities. The Premises License Holder will ensure that a trained member of staff will be on duty and be available to download the CCTV to any of the Responsible Authorities.

The Designated Premises Supervisor and their staff will at all times remain aware of their responsibilities for the prevention of crime and disorder on the premises and demonstrate a responsible attitude to the marketing and sale of alcohol Any person who appears drunk /aggressive will not be permitted on the premises.

c) Public safety

Suitable fire extinguishers, fire alarms and fire exits are maintained.

I will fully support any directives received from the authorities

Floor staff will conduct physical sweep inside the premises to remove hazardous objects/waste as deemed necessary by the management. The Designated Premises Supervisor is aware of his responsibilities to the staff and customers in respect of public safety and will take all reasonable steps to ensure the maintenance of all provided safety arrangements and equipment in accordance with the requirements of current installations.

d) The prevention of public nuisance

All deliveries will be received during daytime to control noise nuisance. In conjunctions with the steps proposed for the prevention of crime and disorder objectives, the Licensees and staff will at all times remain responsible for the prevention of public nuisance in and around the premises.

The Designated Premises Supervisor will arrange to monitor levels from both inside and outside the premises and remedial action will be taken as appropriate. Doors and windows will be kept closed as deemed necessary by the Designated Premises Supervisor. An incident log will be maintained.

e) The protection of children from harm

We recognise the importance of protecting children from harm and this is supported by our commitment to health and safety in the operation and maintenance of the premises and also our approach to managing the risk of under age drinking. The Designated Premises Supervisor and staff will at all times remain aware of their responsibilities under the objective, including that alcohol shall not be sold to anyone under the age of 18. Staff on duty will be trained and made aware of a challenge 25 policy and the requirements and the need to demand an acceptable form of age id. No adult entertainment is permitted at these premises

The premises will operate Challenge 25 policy. Refusals register will be maintained.

NOTES ON DEMONSTRATING ENTITLEMENT TO WORK IN THE UK

Entitlement to work/immigration status for individual applicants and applications from partnerships which are not limited liability partnerships:

A licence may not be held by an individual or an individual in a partnership who is resident in the UK who:

- does not have the right to live and work in the UK; or
- is subject to a condition preventing him or her from doing work relating to the carrying on of a licensable activity.

Any premises licence issued in respect of an application made on or after 6 April 2017 will become invalid if the holder ceases to be entitled to work in the UK.

Applicants must demonstrate that they have an entitlement to work in the UK and are not subject to a condition preventing them from doing work relating to the carrying on of a licensable activity. They do this in one of two ways: 1) by providing with this application copies or scanned copies of the documents listed below (which do not need to be certified), or 2) by providing their 'share code' to enable the licensing authority to carry out a check using the Home Office online right to work checking service (see below).

Documents which demonstrate entitlement to work in the UK

- An expired or current passport showing the holder, or a person named in the passport as the child of the holder, is A British citizen or a citizen of the UK and Colonies having the right of abode in the UK [please see note below about which sections of the passport to copy].
- An expired or current passport or national identity card showing the holder, or a person named in the passport as the child of the holder, is a national of a European Economic Area country or Switzerland.
- A Registration Certificate or document certifying permanent residence issued by the Home Office to a national of a European Economic Area country or Switzerland.
- A Permanent Residence Card issued by the Home Office to the family member of a national of a European Economic Area country or Switzerland.
- A current Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the holder indicating that the person named is allowed to stay indefinitely in the UK, or has no time limit on their stay in the UK.
- A current passport endorsed to show that the holder is exempt from immigration control, is allowed to stay indefinitely in the UK, has the right of abode in the UK, or has no time limit on their stay in the UK.
- A current Immigration Status Document issued by the Home Office to the holder with an endorsement indicating that the named person is allowed to stay indefinitely in the UK or has no time limit on their stay in the UK, when produced in combination with an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A birth or adoption certificate issued in the UK, when produced in combination with an official document giving the person's permanent National Insurance number and their name issued by a Gövernment agency or a previous employer.
- A birth or adoption certificate issued in the Channel Islands, the Isle of Man or Ireland when produced in combination with an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A certificate of registration or naturalisation as a British citizen, when produced in combination with an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.

- A current passport endorsed to show that the holder is allowed to stay in the UK and is currently allowed to
 work and is not subject to a condition preventing the holder from doing work relating to the carrying on of a
 licensable activity.
- A current Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the holder which indicates that the named person can currently stay in the UK and is allowed to work relation to the carrying on of a licensable activity.
- A current Residence Card issued by the Home Office to a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights or residence.
- A current Immigration Status Document containing a photograph issued by the Home Office to the holder with an endorsement indicating that the named person may stay in the UK, and is allowed to work and is not subject to a condition preventing the holder from doing work relating to the carrying on of a licensable activity when produced in combination with an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A Certificate of Application, **less than 6 months old**, issued by the Home Office under regulation 18(3) or 20(2) of the Immigration (European Economic Area) Regulations 2016, to a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights of residence.
- Reasonable evidence that the person has an outstanding application to vary their permission to be in the UK
 with the Home Office such as the Home Office acknowledgement letter or proof of postage evidence, or
 reasonable evidence that the person has an appeal or administrative review pending on an immigration
 decision, such as an appeal or administrative review reference number.
- Reasonable evidence that a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights of residence in exercising treaty rights in the UK including:
 - evidence of the applicant's own identity such as a passport,
 - evidence of their relationship with the European Economic Area family member e.g. a marriage certificate, civil partnership certificate or birth certificate, and
 - evidence that the European Economic Area national has a right of permanent residence in the UK or is one of the following if they have been in the UK for more than 3 months:
 - (i) working e.g. employment contract, wage slips, letter from the employer,
 - (ii) self-employed e.g. contracts, involces, or audited accounts with a bank,
 - (iii) studying e.g. letter from the school, college or university and evidence of sufficient funds; or
 - (iv) self-sufficient e.g. bank statements.

Family members of European Economic Area nationals who are studying or financially independent must also provide evidence that the European Economic Area national and any family members hold comprehensive sickness insurance in the UK. This can include a private medical insurance policy, an EHIC card or an \$1, \$2 or \$3 form.

Original documents must not be sent to licensing authorities. If the document copied is a passport, a copy of the following pages should be provided:-

(i) any page containing the holder's personal details including nationality;

(ii) any page containing the holder's photograph;

(iii) any page containing the holder's signature;

(iv) any page containing the date of expiry; and

(v) any page containing information indicating the holder has permission to enter or remain in the UK and is permitted to work.

If the document is not a passport, a copy of the whole document should be provided.

Your right to work will be checked as part of your licensing application and this could involve us checking your immigration status with the Home Office. We may otherwise share information with the Home Office. Your licence application will not be determined until you have complied with this guidance.

Home Office online right to work checking service

As an alternative to providing a copy of the documents listed above, applicants may demonstrate their right to work by allowing the licensing authority to carry out a check with the Home Office online right to work checking service.

To demonstrate their right to work via the Home Office online right to work checking service, applicants should include in this application their 9-digit share code (provided to them upon accessing the service at <u>https://www.gov.uk/prove-right-to-work</u>) which, along with the applicant's date of birth (provided within this application), will allow the licensing authority to carry out the check.

In order to establish the applicant's right to work, the check will need to indicate that the applicant is allowed to work in the United Kingdom and is not subject to a condition preventing them from doing work relating to the carrying on of a licensable activity.

An online check will not be possible in all circumstances because not all applicants will have an immigration status that can be checked online. The Home Office online right to work checking service sets out what information and/or documentation applicants will need in order to access the service. Applicants who are unable to obtain a share code from the service should submit copy documents as set out above.

NOTES ON REGULATED ENTERTAINMENT

In terms of specific regulated entertainments please note that:

- Plays: no licence is required for performances between 08:00 and 23:00 on any day, provided that the audience does not exceed 500.
- Films: no licence is required for 'not-for-profit' film exhibition held in community premises between 08.00 and 23.00 on any day provided that the audience does not exceed 500 and the organiser (a) gets consent to the screening from a person who is responsible for the premises; and (b) ensures that each such screening abides by age classification ratings.
- Indoor sporting events: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000.
- Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000. Combined fighting sports – defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts – are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
- Live music: no licence permission is required for:
 - o a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
 - o a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises
 of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500,
 and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local
 authority concerned, or (ii) the school or (iii) the health care provider for the hospital.
- Recorded Music: no licence permission is required for:

o any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.

 any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.


