Cllr Alden raised his concerns about not following the statutory time limit for being advised of the meeting and receiving the agenda 5 clear days of the meeting. Therefore the members could not proceed with the meeting. However they could agree to waive the statutory notice limit if they were all in agreement. Cllr Pears also seconded this.

The Chairman asked for the legal position on this and that if everyone was in agreement then could resolve to continue with the meeting. SKB advised that Cllr Alden was correct with regards to the statutory guidance as contained in the Local government Act 1972 and members could waive this provision if they felt appropriate to do so. SKB apologised for the delay in the send out of committee papers and stated that he takes full responsibility for the delay. The reasons were due to work pressures which resulted in not being able to carry out this function in addition to the other work on hand. The Chairman interceded on this point and stated that there is a real wider issue about support to T&C committee and that it has not had committee support from committee secretariat for several years and will be speaking to the leader.

The Chairman advised that the board are to provide a report to the council as trustee in June/July 2016, but this timetable may slip.

Councillor Alden commented that it would be good for them to get this going and queried about the lease at peppercorn rate. NGO advised that the capital sum had a number of conditions attached to it. Members then discussed issues around financial and legal set up of the board.

The Chairman advised that there were 2 Board places for BCC nominees, which included a nomination from the ward members. The appointment is for a three year initial term and could change. The report is proposing the Chairman and Councillor Trickett as nominees.

Councillor Alden commented that the Council may want to appoint for a number of years so as to safeguard that someone is always in place.

1. Purpose of report:

- 1.1 To update the Committee on matters relating to The Stables, which is part of the Cropwood Estate, Registered Charity No. 1085296.
- 1.2 This matter was not included in the Forward Plan because the governance of Charitable Trusts does not give rise to any "key" decisions.

2. Decision(s) recommended:

- 2.1 To approve the incorporation of The Stables building into the general Cropwood portfolio of buildings currently occupied by Hunters Hill School, thus enabling the school to start reproviding outdoor learning education which meets the objectives of the Charity.
- 2.2 To instruct officers in Legal Services and Corporate Finance to take all necessary steps to facilitate the transfer of The Stables to the general Cropwood portfolio of school buildings.

4. Compliance Issues

4.1 <u>Are the recommended decisions consistent with the Council's policies, plans and strategies?</u>

The objects/purposes of the Council's charitable trusts, all have a commonality, namely for the benefit of the citizens of Birmingham. This is consistent with the Council's Policies, Plans and Strategies which are focused on "fair, democratic and prosperous Birmingham." The specific objects of the Cropwood Estate trust are wide ranging and are: the furtherance of any charitable purpose for the benefit of the inhabitants of the city of Birmingham including all or any of the following purposes (a) the provision and support of educational facilities (b) the provision and support of facilities for recreational and other leisure time occupation with the object of improving the conditions of life for the said inhabitants (c) the relief of the aged, impotent and poor (d) the relief of sickness.

4.2 <u>Financial Implications</u>

See paragraph 5.7.

4.3 Legal Implications

Management and governance arrangements for Charitable Trusts are set out in the constitution under which they were established. Charity Trustees must also comply with Charities Act 2011, Trustee Act 2000, other relevant legislation and guidance issued by the Charity Commission. The assets of a charity must be used in accordance with charitable law, failing which gives rise to a breach of trust. Legal sanction can follow from either the beneficiaries of the charitable trust and/or Charity Commission. Decisions made by the charity must be expedient in the interests of the charity at all times. The main area of land comprising the Cropwood Estate was gifted to the City by Barrow Cadbury and Mrs Geraldine S Cadbury on 1st June 1921 with a further parcel gifted on 20th May 1938 and is approximately 35 hectares. Land not directly used by the school is let on an agricultural tenancy. The trust is governed by a scheme dated 12th November 1997.

4.4 Public Sector Equality Duty

None. The statutory functions discharged by the Council as Trustee are subject to a separate and distinct statutory regime underpinned (principally) by the Charities Act 2011, Trustee Act 2000 and relevant Charity Commission guidance. These are non-executive functions and are therefore not subject to the Equalities Act 2010 provisions.

5. Relevant background/chronology of key events:

- 5.1 On 17th March 2014 Cabinet approved the decision to decommission Birmingham City Council's Outdoor Education Service (OED). The Outdoor Education Service had used some of the buildings on the Cropwood Estate, which is part of the Cropwood Trust, known as The Stables.
- 5.2 Following the closure of OED The Stables was mothballed and Hunters Hill Special School (which is situated opposite The Stables) has managed the empty building on

- behalf of Birmingham City Council Education Infrastructure to ensure that the building did not deteriorate or become subject to vandalism.
- 5.3 Hunters Hill is a secondary school for pupils with social, emotional and mental health issues. The school has always played a major part in providing Outdoor Education at The Stables, thus building up their expertise in this particular area.
- Recognising the valuable nature of the services that were provided from The Stables for Birmingham pupils, particularly those with a higher level of needs, Hunters Hill School has expressed an interest in re-establishing the outdoor education facility operating from The Stables and to start re-providing a wide range of outside learning opportunities. These would include traditional outdoor adventure activities and camping. In addition the School wish to develop the fields and space adjacent to The Stables to accommodate a range of animal and horticultural programmes as part of a Land Based Studies programme offering academic, vocational and therapeutic benefit for both primary and secondary age children.
- Hunters Hill School's Business Case not only renews an important part of Birmingham pupils' education through providing outdoor learning but also plans to extend the offer by becoming a base for a Forest School and would start to run programmes to follow therapeutic wilderness activities in the grounds.
- 5.6 Hunters Hill School propose to develop a sustainable Business Plan that would allow them to open these programmes to all schools in Birmingham and neighbouring authorities, thus allowing the original Cropwood Trust Deed of Gift to be fulfilled which is essentially that the building, its resources and its environment are there for the benefit and enjoyment of the children of Birmingham.
- 5.7 Hunters Hill School would become responsible for all running costs associated with The Stables. At the present moment minimal running costs e.g. gas, electricity, rates etc. are being funded by the Education Infrastructure Department.
- 5.8 Education Infrastructure fully support Hunters Hill School in this venture and subject to the Trust and Charities Committee agreement, Hunters Hill School is prepared to accept responsibility for The Stables with immediate effect with a view to bringing the building back into use.

6. Evaluation of alternative option(s):

6.1 If the Committee determine not to allow Hunters Hill School to use The Stables for outdoor activities, the building will continue to be mothballed and over time the fabric of the building will inevitably start to deteriorate.

7. Reasons for Decision(s):

7.1 To approve the awarding of a lease to Hunters Hill School to allow them to occupy The Stables and to start re-providing a wide range of outside learning opportunities.

SUBJECT:	SURRENDER AND RENEWAL OF LEASE AT 187 HARBORNE LANE (SELLY OAK PARK (REGISTERED CHARITY NO.522877)
Wards affected:	Selly Oak

1. Purpose of report:

1.1 To consider the surrender and renewal of the lease of 187 Harborne Lane, which is part of Selly Oak Park, held in trust.

2. Decision(s) recommended:

That Committee:

- 2.1 approves the proposal to accept the surrender of the existing lease and grant two new leases on the same land, each for 125 years.
- 2.2 approves the terms of any disposal being negotiated and agreed by the Director of Property acting as agent on behalf of the Trust, including change of use to permit uses as described in C2 and C2A of the Town and Country Planning (Use Classes) including student accommodation.
- 2.3 authorises the recommendations of the Trusts and Charities Committee to be advanced to the next available meeting of the Council as Trustee for approval.
- 2.4 authorises any further approval necessary is sought of the Charity Commission or descendants of the original transferors of the land, or other bodies as appropriate and to agree to make any applications necessary for appropriate powers of disposal.
- 2.5 authorises the City Solicitor to place any formal advertisements required under s123 2(a) of the Local Government Act 1972 for the loss of public open space (if any) or required under any of the various statutes as may relate to the charitable status of the land including any appropriate consultation stages and to appraise the Committee of the results of that consultation.
- 2.6 authorises the City Solicitor to prepare, negotiate, execute, seal and complete all necessary legal documentation to give effect to the above decisions.

3. Consultation

Consultation should include those that have an interest in the decisions recommended.

3.1 Internal

Officers in the Parks Service have been consulted and have raised no objections.

3.2 External

No additional separate consultation is envisaged except where further consultation locally may be required to satisfy the requirements of the Charity Commission and the various Charities Acts.

4. Compliance Issues:

4.1 <u>Are the recommended decisions consistent with the Council's policies, plans and strategies?</u>

The objects/purposes of the Council's charitable trusts all have a commonality and principally are held for the benefit of the citizens of Birmingham. Actions proposed are required to be in the best interests of the trust and are intended to preserve the trust estate for the future while consistent with the Council's Policies, Plans and Strategies.

4.2 <u>Financial Implications</u>

(Will decisions be carried out within existing finance and resources?)

The property is already leased long term but has been vacant for several years pending a suitable new use. There will be no direct cost in proceeding with the proposed new lease as the tenant will pay all landlords legal and surveyors costs. The substantial increase in rental income will be of general benefit.

4.3 Legal Implications

Management and governance arrangements for Charitable Trusts are set out in the constitution under which they were established. Charity Trustees in making decisions must also comply with Charities Act 2011, Trustee Act 2000, other relevant legislation and guidance issued by the Charity Commission. The assets of a charity must be used in accordance with charitable law, failing which this will give rise to a breach of trust. Trustees have a duty to preserve the assets of the trust. Decisions made by the charity must be expedient in the interests of the charity at all times. The disposal of trust assets is an exceptional event and must be in line with appropriate professional advice. All valuation advice conforms to the requirements in Part 7 Charities Act 2011 for the disposition of trust land. The grant of a long lease is a disposal for these purposes.

The City Council is Sole Corporate Trustee of a number of charitable trusts and has delegated day to day management decisions in respect of these trusts to the Trusts and Charities Committee with decisions on other matters being approved at meetings of the Council as Trustee. Proposals for the management of land in trust or of services thereon require robust procedures to safeguard the Trust and the public using the parkland and buildings to comply with charity law. Charitable activity is further regulated by the Charity Commission. Section 19 of the Local Government (Miscellaneous Provisions) Act 1976 allows the City Council powers to amend services and meets the Council's regulations and standing orders.

4.4 Public Sector Equality Duty (see separate guidance note)

N/A. The statutory functions discharged by the Council as Trustee are subject to a separate and distinct statutory regime underpinned (principally) by the Charities Act 2011, Trustee Act 2000 and relevant Charity Commission guidance. These are non-executive functions and are therefore not subject to the Equalities Act 2010 provisions. However an Equality Impact Assessment has been undertaken for the Cabinet report. No decision on a new lease will take place until the 'Council as trustee' have considered the matter further.

5. Relevant background/chronology of key events:

- Selly Oak Park is formed from a number of acquisitions and is mostly held in trust as Registered Charity no.522877 k/a Public Park and Pleasure Ground Birmingham Selly Oak Park registered 01 October 1963. The City acquired the specific part of the Park when the land was gifted by William John, William W and Robert L Gibbins on 31/12/1919. The Gibbins family were a very prominent family in the area at the time. No. 187 Harborne Lane is the site of the former park keeper's lodge which was demolished in the 1980's. The trust deed contained a restrictive covenant limiting the use of the land generally to recreational purposes (public open space). In 1988, a Deed of Release was obtained to relax the covenants on this section permitting the use of the building to allow "care for old people." A 99 year lease was then granted and the care home property erected.
- 5.2 In May 2007, the nursing home closed as a result of changes in legislation making many care homes nationally non-compliant and financially unviable.
- 5.3 In 2013 the lease was assigned and the new tenant sought landlords consent to extend the term of the existing lease and to a change of use from 'care for old people' to uses as described in C2 and C2A of the Town and Country Planning (Use Classes) Order 1987 (as amended) including student accommodation. There is substantial demand for accommodation for employees of the two hospitals in the vicinity as well as general demand from university students. Planning consent to convert the existing building in to a 21 bed student accommodation block and a new stand-alone accommodation block for 9 student apartments has been granted. The conversion of the existing building has been undertaken and is fully occupied.
- 5.4 Negotiations to surrender and re-grant the lease have been on-going for some time and the main terms have now been agreed. The new terms will give the trust a greatly increased annual income and the ability to review the rent to market value every 7 years as opposed to the current lease which only doubles the passing rent every 25 years. Plans of the existing and proposed leases attached as Appendix 1 and 2. It is anticipated that a further Deed of Release will now be required in addition to other consents for the disposal.

5.5 Aims and Objectives of the Charity

Each park is held as a separate trust and decisions need to be in the best interests of that trust. The area leased is separated from the main park by the line of the former Lapal Canal though still subject to charitable objects generally. There was also a potential requirement of land within the lease to assist the restoration of the Lapal Canal by the Lapal Canal Trust in reconstructing a turning circle on the bridge. However most recent plans for the canal development no longer include the leased land and so terms have recently been agreed which include the full area of the existing lease.

5.6 Trustee Powers

The charity's constitution is set out within the executed Trust Deed for each park principally the acquisition deeds or as amended by a scheme agreed with the Charity Commission. All decisions will be mindful of the original intention set out in the documents however subject to compliance with Charity law and Part 7 Charities Act 2011 sufficient powers also exist for the Trustees to make decisions on the future of the assets including disposal in the Trustee of Land and Appointment of Trustees Act 1996.

5.7 Charity Finances

Formal accounts are required to be prepared for the Charity Commission returns where appropriate although income at Selly Oak Park is below the threshold and far exceeded by general maintenance obligations for the parkland with all duties undertaken by BCC Parks Service.

- 6.1 Do nothing. There is not a 'do nothing' option. Action must be taken as the Lessee is legitimately in occupation but currently operating a business without full consent of the landlord, and the passing rent is minimal.
- 6.2 Take legal action against the Tenant to stop using the building as student accommodation. This would incur legal fees and would prevent the development of land and increased income to the Council. It would also deny an opportunity to provide much needed affordable accommodation near to the hospitals when there appear to be very few other options for the site except standard residential development.

7. Reasons for Decision(s):

7.1 To safeguard the Trust's assets, secure legitimate occupation and maximise income from land held by the Trust while bringing vacant buildings back into beneficial use.





Appendix 1 – Trusts & Charities Committee Meeting 20 April 2016 TRUSTS & CHARITIES COMMITTEE - APPOINTMENTS PROTOCOL PANEL (the "Panel")

MEETING 8th MARCH 2016

Members: Councillors Philip Davis, John Alden and Paul Tilsley

Background

- 1. The City Council had historically made a number of appointments of trustees to charitable bodies across the City. The Trusts & Charities Committee (the "Committee") had asked the Panel to consider how links to charities and trusts might be improved in terms of an improved appointments process to appropriate charities. This inquiry is partly promoted by poor attendance at trustee boards by some Council nominees once nominated, or the long-standing absences of nominees despite requests to fill trustee places.
- 2. While the assumption is that most appointments should remain with Cabinet directly, some charity trustee appointments could more appropriately come via the Committee, which already, for example, receives annual accounts for noting from some of the charities concerned. The Committee was chiefly concerned with 'historic' trusts or trusts related to assets held in trust e.g. The Highbury Estate. Here the City, via the Committee, had a natural and legal connection to the charity or trust concerned.
- 3. The City Council has key relationships with a number of 'strategic' charitable trusts for example the Library of Birmingham and the Birmingham Museums Trusts. No change is suggested for appointments to this category of trusts.
- 4. Birmingham Conservation Trust ("BCT") recently reviewed its structure and has already asked if the Committee could nominate City trustees to its board, given its work on assets held in trust. BCT has, however, a historic relationship with the City Planning Department, so the views of Cllr Mike Sharpe, Planning Chairman should be sought.

Proposals made by the Panel

- 5. The Panel is considering how the appointment process could meet certain principles. It is suggested that Appointed Trustees should be:
 - A Birmingham resident (preferable, but not compulsory)
 - Regarded as equivalent to a voluntary Non Executive Director role, with appropriate
 attendance and diligence required. A 'Statement of Responsibilities' should be drawn up
 (unless already existing in City Codes of Conduct), in addition to Guidance issued by the
 Charity Commission on the roles and responsibilities of a Trustee (the "Essential TrusteeWhat you need to know")
 - Requested to Report at least annually to the Committee on the work of the appropriate charitable trust.
 - Subject to removal at any point by decision of the Committee on advice from the City Solicitor and Monitoring Officer

Future Nominations

- 6. To assist in the nomination process any new Committee procedure should have regard to the following principles/procedure:
 - Nominations should initially be sought via elected Members i.e. Members may put themselves forward, or put forward Non- Members, though the decision to appoint remains with the Committee;
 - Nominations may be received and considered by the Committee by the external body themselves

Further action

Officers will assist the Panel to compile a list of relevant charitable trusts appropriate for Committee appointments.

Once the list is compiled, the Panel Members will liaise with the Chairman of District Committees for local perception of which charitable trusts are active in their Districts, if any, to better inform potential Committee appointment process.

Committee Services will provide the Panel with a definitive list of all charitable bodies the Council nominates to.

Councillor Davis will prepare note of today's Panel meeting and arrange another Panel meeting (if required).
