Advice from Birmingham Public Health colleagues has been sought in advance of this decision. The advice being "In view of the current situation with the infection rate of variants of concern rising and the fact that we now have also identified cases amongst the homeless population, the public health risks are still present." Monika Rozanski, Service Manager – Health Protection Response.  It is noted that government will announce on the 14th June 2021 the extent to which lockdown will ease on the 21st June 2021. It was timetabled as the earliest date on which all restrictions would be lifted. Current commentary (at time of decision making) suggests that some restrictions may remain. Yes	Director City Operations	The report summarises the Council's position in relation to its contract with Birmingham Community Leisure Trust (BCLT) for the operation of 9 community sport facilities affected by COVID-19. It sets out the options for the Council in supporting the provider through the pandemic and recommends that their application for supply chain support measures is supported in line with the emergency process set out by the Business and Economic Recovery Cell.  The supplier relief programme seeks to utilise open book accounting to make our suppliers in a "no better, no worse" position without the delays and costs associated with lengthy contractual disputes, while at the same time providing our leisure operators with the confidence to be able to respond to the government announcements on re-opening and operating under Covid-19 restrictions.  Having followed this process previously BCLT were awarded £1.142m for the period 1st April thru 31st June 2020 (Quarter 1), £1.172m for the	During the 2020/21 financial year Central Government announced on several occasions the temporary closure and/or associated operational restrictions of all gyms and leisure centres as part of its COVID-19 response to stop the spread of infection. The Health Protection (Coronavirus Business Closure) (England) Regulations 2020 and subsequent related legislation is interpreted by leisure operators nationwide as an effective 'change of law' in contractual terms.
