Brief description of the proposal: Approval is sought to progress to Cabinet approval for the acceptance of additional ringfenced grant funding for 2024/25 from the Department of Health and Social Care to enhance and develop local stop smoking services and support. The additional grant of £1,676,048 will support the Public Health Division's additional planned procurement for Smoking Cessation services in adherence to the recently introduced Provider Selection Regime with a Direct Award Process being followed. The Cabinet Meeting that is being worked to will be held on 23rd April 2024. The Adults Team will seek to engage providers with a targeted approach before and during any new procurement processes to mitigate the risk of low engagement with the tender opportunity. The Adults Team will use this additional funding alongside its existing Public Health Ring Fenced Grant smoking cessation budget to increase service provision. It will have no impact on the General Fund.

				NRT packaging is mostly recyclable, however the vapes available as part of the service do include both reusable and disposable options. Disposable vapes and batteries are recyclable but must be taken to a dedicated disposal centre. We are aware of a partnership between a vape company and Veolia that specialises in safe battery disposal which we will sign post our smoking Icessation providers to.

However, by having a wider geographical coverage of smoking cessation service providers Birmingham citizens will have more choice. This could result in service users not travelling as far to access these services. This would result in shorter and fewer journeys which feeds into the wider Council plan priority regarding tackling climate change and delivering the Route to Zero aspirations.
